## 1. Introduction

The ET subject is highly relevant to effective coping with the existential threats facing us today. A key figure in highlighting this truth is the late Philip Schneider (1947 – 1996), whose findings are presented in Aliens 3. As Philip Schneider stated in 1995, before he was tortured and murdered in January 1996: The present government rules over us like kings and queens over serfs, We have to get the message out, This country is not going to a New World Order, Our patriot movement will kick the parasites out!

The aim of the five Aspects of Aliens posts is to help clarify the ET subject for the purpose of more informed action against the evil-doers of our times.

## 2. The Anunnaki

The Anunnaki (meaning “those who came down from the heavens” or more accurately, “those who from Anu to the Earth came or were sent”)<sup>4</sup> are a highly advanced humanoid ET species. The above image shows a carving of an Anunnaki (named Enlil) from about 2,500 BC wearing a Cross necklace (the Cross, like the Solar Wheel and the Swastika, symbolizes the supreme deity and spiritual enlightenment, as is explained in the post [From ET to Enlightened Time](#)). The image also shows five symbols representing a goddess, a god, and star systems that the Anunnaki worshipped. Clockwise from the bottom, the symbol and its meaning:

- **Eight-pointed star** — Ishtar (worshipped in Sumer as Inanna and later as Ishtar

by the Akkadians, Babylonians, and Assyrians), Queen of Heaven and goddess of love, war, and fertility.

- **Shooting star** — Barnard’s Star in the Orion constellation and therefore Orion.
- **Shamash disc** — Shamash the sun god (he sees everything that happens in the world and is responsible for justice and protection of travellers), the sun and the brightest star in the night sky, Sirius, also called Alpha Canis Majoris or the Dog Star.
- **Crescent Moon** — the Moon (the Moon symbol is often seen with seven stars around it to represent the seven stars of the Pleiades star cluster), associated with the above-mentioned goddess Inanna / Ishtar.
- **Triple chevron** — the Hyades star cluster, which is V-shaped.<sup>4,5,6</sup>

Clearly the Anunnaki religion is natural (pagan), like that of human pagans.

### 3. Anunnaki creation of human and other life

Sumerian Cuneiform clay tablets from ancient Mesopotamia (uncovered in the 17th century) record the arrival of Anunnaki on Earth in flying ships about 432,000 years ago [subsequently, about 300,000 years ago, anatomically modern humans started to emerge], their genetic engineering of the human species, civilization of humans in Sumeria and elsewhere, and their worship as gods by the Sumerians, Babylonians, Assyrians and Akkadians.<sup>4,7</sup>

The Anunnaki feature in the Babylonian creation myth, Enuma Elish, and they are mentioned in The Epic of Gilgamesh when Utnapishtim tells the story of the flood.<sup>7,8,9</sup>

Specifically, the tablets record:

- In an African laboratory the gods Enlil (represented in the above image) and his brother Enki, and the goddess Ninmah (Enlil’s half-sister) genetically engineered and gave birth to “Adam,” the archetype for the human race, and then “Eve.”
- The Anunnaki created humans for the purpose of doing primitive work.
- These deities taught all aspects of civilization to Sumerians, e.g. agriculture, building, writing, mathematics.
- On or before 3,760 BC, Enki’s father Anu assigned Enki to the regions of Egypt and Africa, Enlil to Mesopotamia, and a granddaughter named Inanna (the goddess referred to above) to the Indus Valley region.<sup>4</sup> [This fits with the dates of civilization appearing in these regions: Sumer / Mesopotamia c. 4,500 BC, Indus Valley c. 3,300 BC, Egypt c. 3,100 BC]
- Enki (later referred to as “Ea” in Babylonian and Akkadian mythology), one of the chief Sumerian gods, created seven demigods (the Apkallu) to teach humans the

arts of civilization (agriculture, building, writing, mathematics etc).

- It seems that the Apkallu bred with humans to create the Apkallu x human hybrid known as Nephilim, a word that could mean “giants,” “ones who have fallen,” or “those that cause others to fall down.”
- The Nephilim were destructive rulers who enslaved and exploited humankind.<sup>7</sup>

As biblical stories draw on pagan myth, Sumerian accounts of the Nephilim are echoed in Genesis 6:1-4, Numbers 13:32–33 and the Book of Enoch. The implication of these biblical references is that the Nephilim:

- Were the sons of Anak (a word for “giant,” “long neck,” “necklace,” and “ruler”).<sup>10</sup>
- Lusted after human females, took them as wives and produced hybrid Nephilim x human children.
- Were destructive rulers who enslaved and exploited humankind.

As the Nephilim DNA spread across the human population, to varying extents the Nephilim became us.<sup>7</sup>

## 3.1 Supporting evidence

### 3.11 Historical

#### Ancient Egypt

The rule of Enki in Egypt at the claimed time is consistent with the delineation of Egyptian civilization into three dynasties by the Greek historian Herodotus, who lived in the 5th century BC.<sup>4</sup>

#### The Nommo

According to oral traditions of the Dogon tribe in Mali, West Africa, the Nommo are an ET race from the Sirius star system who visited Earth thousands of years ago. This race is amphibious (a race of Fish people) and resemble mermen and mermaids. These beings also appear in Sumerian, Akkadian and Babylonian myths. The Egyptian Goddess Isis is also linked with the star Sirius and is sometimes depicted as a mermaid.<sup>9</sup> As a result of their learning from the Nommo, centuries before it was known to modern scientists, the Dogon already knew that Sirius is actually made up of three stars.<sup>9</sup>

Consistent with Andrew Johnson’s (2019)<sup>11</sup> observation:

- The focus on Sirius in ancient Egypt suggests that the Anunnaki and the Nommo could be the same ET species.
- This would imply that the Anunnaki are amphibians.
- This would explain the aquatic characteristics of human physiology after the Anunnaki genetically engineered humans using some of their own DNA (discussed below).

### 3.12 Scientific

Sumerians showed detailed knowledge of Earth's orbital plane, tilt axis, spherical shape, precession of its equinox, and our solar system. A 6,000 year-old Sumerian cylindrical seal shows an accurate depiction of our solar system and Sumerian texts describe the colours of Uranus and Neptune. Sumerians also constructed the Zodiac. In contrast, modern science only acquired knowledge of our solar system very recently. While the Sumerians and neighbouring peoples had advanced mathematics, metallurgy, law codes and astronomy, as recently as the Middle Ages in Europe, scientists and church authorities argued about whether Earth was round or flat.<sup>4</sup>

### 3.13 Biological

Andrew Johnson (2019) in Acknowledged: A perspective on UFOs, Aliens and Crop Circles (as of p. 246)<sup>11</sup> presents biological evidence that rules out the possibility of humans resulting from evolution and instead supports Anunnaki creation / introduction of humans (together with other animal and plant species) when the environment could support them:

#### Human and chimpanzee differences

Darwinian evolution cannot explain the appearance of Homo Sapiens (humans). Although chimpanzees are supposedly our closest living relatives, we have 46 chromosomes (23 pairs) and they have 48 chromosomes, like all the other primates. It looks like the Anunnaki fused two primate chromosomes together in their creation of humans. Consistent with this evidence of us not being closely related to chimpanzees, chimpanzees are about ten times stronger than humans for a given body weight.<sup>11</sup>

#### Human similarity to marine mammals

Humans have characteristics found in marine mammals but not in any primates. For example, humans have:

- A layer of fat (subcutaneous fat) like walruses, seals and dolphins, and can become very obese.
- Naked skin, like a hippopotamus or an elephant.
- Most of their hair in the opposite places to that of a chimpanzee.
- Locomotion on two feet — as shown by apes when wading through water, this is required when wading in deep water.
- Control of their breathing (e.g. for speech) like diving animals and birds. In contrast, chimpanzees cannot control their breathing to that extent and always keep their heads above water when swimming or wading in deep water.
- Millions of large sebaceous glands that exude oil over the head, face and torso. The only known function of sebum in other animals is to waterproof the skin or fur. In contrast, chimpanzees' sebaceous glands persist only as a rudimentary structure (they are vestigial).
- DNA that is very close to that of dolphin DNA.
- Kidneys that are similar to those of marine mammals.<sup>11</sup>

### 3.131 Genetically engineered hybrids

Domesticated pigs and other animals, together with plants, were developed in the upper reaches of the Euphrates river about 10,000 years ago, i.e. soon after the last glacial retreat started about 11,650 years ago (charts and discussion of this subject are in the post [Are your parasites amusing?](#)). It seems likely that the Anunnaki genetically engineered many animals:

- Cheetahs (a hunting animal for humans) have the head of a cat, the paws and body of a dog, susceptibility to both dog and cat diseases, and are all virtual clones of one another.
- Pigs and humans (but not chimpanzees) share about 80 characteristics. This is consistent with humans being a cross between a pig and a more primitive primate.
- Humans are similar to hybrid mammals in their relatively low fertility, abnormal sperm that is not of one uniform type, and a high percentage of dysfunctional spermatozoa.<sup>11</sup>

## 4. ET and ET x human skulls

### The Starchild skull

The Starchild skull is a 900 year-old bone skull found in Mexico in the 1930s. Scientific analysis of the skull proves beyond any reasonable doubt that it is not human.<sup>11</sup> Andrew Johnson (2019) presents detailed factual information about the Starchild skull as of page 264 in *Acknowledged: A perspective on UFOs, Aliens and Crop Circles*.<sup>11</sup> (In contrast, Wikipedia offers a blatant cover-up on this subject.) For educational videos about this fascinating skull, see the presentations of Lloyd Pye<sup>12</sup> and Andrew Johnson.<sup>13</sup>

As this skull looks very different to the Paracas skull, presumably it is not of Anunnaki / Apkallu / Nephilim ancestry, like the Paracas beings seem to have been. In addition to the DNA evidence of that being an ET skull, to my eyes these skull features are the same / similar to those of the Grey ET as sketched by Bill Uhouse (image and discussion in Aliens 3):

- Cranium to face proportion — the cranium is huge in relation to the face size.
- Cranium shape — pronounced outward flare behind the eye sockets (orbits) into a huge rear (parietal and occipital bones).
- Eye orbit size — high and wide.

The eye orbit shape (including a sharp angle on the upper outside) is different to the upward-sloping oval-shaped eyes sketched by Bill Uhouse, but those orbits look far from human. To me the skull looks like it is of a pure Grey sub-species.

## The Paracas skulls

In 1928 the archaeologist Julio C. Tello discovered a cemetery in the Paracas desert of Peru containing over 300 skulls. Studies of these Paracas skulls showed that they are:

- About 3,000 years old in some cases.
- The largest elongated skulls found anywhere on Earth.
- At least 25% larger and up to 60% heavier than normal human skulls.
- Not artificially deformed by techniques (head binding or head flattening) used by some tribes.
- Structurally different to normal human skulls — (i) only one parietal plate (normal human skulls have two), (ii) the foramen magnum (hole in skull through which spinal cord passes) is back towards the rear of the skull (in a normal skull it is closer to the jaw line) and also smaller than normal, (iii) some of the Paracas skulls have a very pronounced zygomatic arch (cheek bone), different eye sockets, and no sagittal suture (connective tissue joint between the two parietal bones of the skull).
- Genetically very different to humans and (i) the mitochondrial DNA (inherited from the mother) in hair samples showed a Haplogroup (genetic population group) found most frequently in Eastern Europe, and at a low frequency in Western Europe and (ii) a similar analysis of bone powder from the most elongated skull showed a Haplogroup that originates in Mesopotamia (now Syria),<sup>14</sup> i.e. where the Nephilim lived according to ancient Sumerian and biblical texts.
- Dark red and blond-haired. This is consistent with the DNA results — red hair originates in the Middle East and Europe. Also, their red / blond hair is 30% thinner than native American hair.<sup>14,15</sup>
- Nephilim and Nephilim x human hybrids. As was noted above, Nephilim are an ET (the Apkallu, demigods created by the Anunnaki) x human hybrid known as destructive rulers who enslaved and exploited humankind.<sup>14</sup>

According to biologist Brien Foerster (2018)<sup>16</sup> the Paracas were a royal family, had light-coloured skin, probably sensitive eyes, and they lived in underground houses due to the extreme sunshine.

## 5. Other historical evidence of ETs on Earth

## 5.1 Ancient Hindu texts

Bipin Dimri (2021), a writer from India, explains<sup>17</sup> that ET craft are referred to in ancient Hindu texts and religious teachings (Vedas) dating back to the empire of Rama [a Hindu god who lived about 1,250 BC<sup>18</sup>]. Most of the ancient Hindu texts concerning ET craft have not been translated into English. The texts include information on:

- Secrets of gravity and how to master it.
- Construction of the craft using three metals (Somala, Mourthwika, Soundaalika) mixed in certain proportions to form 16 alloys with the necessary heat-absorbent properties.
- Fuel and quicksilver (mercury) used in the craft.
- Craft sizes and shapes, e.g. saucer, sphere, cone, rocket, cylinder, cigar.
- Craft ability, e.g. travel both underwater and in outer space.
- Division of the sky into seven worlds (Lokas) wherein the craft travelled.
- Flight paths, pilot training, navigation, clothing for pilots, food for long flights and propulsion units.<sup>17</sup>

## 5.2 Ancient art

Around the world ancient rock art depicts aspects of prehistoric daily life, including animals, symbols, humans and ETs. In addition to the examples of ET-type figures shown in the above composite image, examples of ETs and their craft in ancient art include:

Cave painting in Itolo, Tanzania, depicting several disc-shaped objects; cave painting in Kolo, Tanzania, showing four entities surrounding a woman and another looking down from inside a box-like object; cave painting in Kiev, Ukraine, showing a suited ET-type figure; cave painting in Tassili, Sahara Desert, North Africa, showing a being in a possible spacesuit helmet above which are disc-shaped objects;<sup>23</sup> rock art in Charama, Chhattisgarh, India of ET-type figures wearing suits like modern space suits, flying saucers with a fan-like antenna and three legs, and the figures carrying what look like weapons;<sup>24</sup> much of the art in caves in and around Lesotho, Southern

Africa, features ET-type beings that look remarkably similar to descriptions of ETs in modern times;<sup>25</sup> and ancient Inca sculptures depicting flying saucers.<sup>23</sup>

In many cases ET encounters recorded in ancient art remain part of the people's culture. For example, south-west Native American tribes (ETs in their ancient art are shown Top R above) believe that "The Sky People" or "The Star People" have supreme knowledge and taught people on Earth how to live according to the positions of the astronomical bodies, universal laws, and navigate through different realms of time and space.<sup>26</sup> Similarly, in Australian Aboriginal mythology, cloud and rain spirits [Wanjina, the ET figures shown Bot L above] remain important to the Mowanjam Community of Aboriginal people;<sup>19</sup> people in the nearby villages of Charama (India) still worship small 'Rohela' people who landed there in flying saucers from the sky;<sup>24</sup> and much of African mythology contains numerous references to entities from another world.<sup>25</sup>

## 5.3 African oral history

### Credo Mutwa (1921 – 2020)

Vusamazulu Credo Mutwa was a Zulu traditional healer (sangoma) from South Africa who spoke and wrote about his encounters with ETs.<sup>27</sup> Following is information from Mutwa published in New Dawn (2008):<sup>28</sup>

- Stories of ETs and UFOs are an important part of African tribal culture.
- ETs ("sky people" or "sky gods") have visited Earth for thousands of years.
- All Africans accept the existence of extraterrestrials and believe that humanity is descended from such beings. In fact the word "Zulu" means people from the stars.
- Some ETs are wise and benevolent toward humans. They have profoundly influenced human civilizations for millennia, e.g. by giving us knowledge of farming, law, arts, science, the cosmos, and herbal medicine.
- ETs referred to in the West as reptilians are known about throughout Africa. This includes the amphibian sky gods known in Africa by names such as Zishwezi and Asa (meaning the mighty ones of magic).



## 6. The degrading: Transhumanism

The Anunnaki were good (in their creation and civilization of us), the Nephilim were bad (in their enslavement and exploitation of us) and the Talmudic aliens (the Cabal) are trying to degrade us in the name of transhumanism. Transhumanism is the ideology driving the Cabal's Great Reset (New World Order, brutal world government by jews).<sup>29</sup> Transhumanism is about trying to enhance humans by means of genetic engineering, biotechnology, and nanorobotics that replace the fully biological body.<sup>29</sup> Transhumanists are trying to defy ageing and nature in its entirety.<sup>30</sup>

### 6.1 Transhumanism in reality

#### Totalitarianism

“Elite” transhumanists seek to advance their own bloodlines and enslave the rest of us.<sup>31</sup> They want to control humanity.<sup>30</sup> Our self-appointed global rulers intend using Big Data, Internet of Things and Artificial Intelligence to control a slave class of sub-humans and hybrids.<sup>29</sup> This includes the use of surveillance technology justified by engineered events (e.g. 9/11) and lies (e.g. “global warming / climate change,” “pandemic”) to advance the World Economic Forum (WEF) agenda.<sup>32</sup>

In 2018 “Advisor” to the WEF Israeli jew Yuval Noah Harari addressed the WEF. He stated that the (supposed) transhumanist future “. . . will be decided by the people who own the data,” “When the infotech revolution merges with the biotech revolution, what you get is the ability to hack human beings.” “. . . the outcome could be the rise of digital dictatorships. . . . we are seeing the formation of more and more sophisticated surveillance regimes throughout the world,” “. . . a tiny elite may come to control not just the future of human societies, but the shape of life forms in the future.”<sup>33</sup> In his 2020 address to the WEF, Harari stated that humans are now “hackable animals,” there is the potential for “the worst totalitarian regime in human history,” “[Humans] are likely to lose control over our own lives . . . .”<sup>33</sup>

There is evidence to suggest that the “vaccines” are in fact material to enable the integration of humans with the Internet of Things / Internet of Bodies, with humans and their devices no longer fully separate entities.<sup>34</sup> The “vaccine” contains extremely dangerous carbon nanotubes and self-assembling intra-body nano network technology. This nanotechnology is an interface between the human body and computers via 5G. It is what the Internet of Things is really all about — constant uploading of personal information to the cloud for analysis that enables tracking and total control of “vaccinated” people.<sup>35,36</sup>

## Deception

Behind the scenes of international conflict is one conglomeration of technophiles at war with humanity at large. The attackers use deception (e.g. lies about “global warming / climate change,” fake “pandemic,” toxic “vaccinations” presented as necessary and therapeutic, fake threats of foreign nations) to try control humanity. The attack is via numerous overlapping organizations that the attackers control, including universities, the military-industrial complex and the medical-industrial complex and it involves their 5G roll-out, Internet of Things devices, artificial intelligence, vast data aggregation for remote monitoring and immediate reaction, end-to-end digital enabling infrastructure tied to biometric data, and social credit scores in a hellish electronic prison run by world government gangsters.<sup>37</sup>

In reality there was no pandemic (e.g. Prof. Christian Perronne<sup>38</sup> 2021, French

vaccine expert; and Doctors for COVID Ethics<sup>39</sup> 2021) and the “vaccine” is not a vaccine.

This deception and attack on our health was planned a long time ago. Fifty years ago the World Health Organization published its intention to study ways in which the immune system can be weakened in Bulletin of the World Health Organization, Vol. 47, No. 2, 1972.<sup>40</sup> Excerpt from this WHO publication:

1. An attempt should be made to ascertain whether viruses can in fact exert selective effects on immune function, e.g., by depressing 7S versus 19S antibody, or by affecting T cell function as opposed to D cell function (Allison et al., 1971).
2. The possibility should also be looked into that the immune response to the virus may itself be impaired if the infecting virus damages more or less selectively the cells responding to the viral antigens.
3. If this proves to be the case, **virus-induced immunodepression might conceivably be highly instrumental** in prolonging certain virus infections, such as murine leukaemia, hepatitis, sub acute sclerosing panencephalitis, or infections caused by LDV, LCMV, or ADV.

The first clinical reports of HIV/AIDS were in 1981<sup>41</sup> and there are reasons to suspect that the retrovirus was introduced via “contaminated vaccinations, specifically the hepatitis B produced initially in chimpanzees and rhesus monkeys between 1970 and 1974 . . . .” (Dr. Len Horowitz<sup>42</sup>).

## Mass murder

The “vaccination” is potentially the biggest genocide in history. The Covid “vaccination” destroys immune function. For example, from Stephanie Seneff, Ph.D. in an interview with Dr. Joseph Mercola<sup>43</sup> about her publication in 2022:

The “vaccine” suppresses the immune system, leading to increased cancer cases in “vaccinated” people. On average there are twice as many reports of cancer after the “vaccination.” The incidence of breast cancer is three times higher after the “vaccination.” Similarly, the weakened immune system allows latent viruses like herpes and varicella (which causes shingles) to emerge. Dr. Seneff anticipates a dramatic increase in infections and cancers of all types. Each “vaccination” erodes the immune response, resulting in it becoming increasingly weak with each jab.

More recently, in “Covid Vaccine Destroys Natural Immunity” (Sep 2022)<sup>44</sup> Will Jones reviews relevant medical research and concludes: The “vaccines” appear to demolish a person’s natural immunity, leaving him/her more vulnerable to infection

than before.

In addition there are numerous other “vaccine” injuries, including damage to the brain, heart and other organs; limb amputations; high blood pressure; Bell’s palsy; headache; tinnitus; uncontrollable tremors and shaking; loss of mobility; loss of smell and ability to swallow (dysphagia) which are both signs of Parkinson’s disease; Alzheimer’s disease; CJD (Creutzfeldt-Jakob disease — a terrible disease that cripples and kills within a few years); infertility; fetal damage; miscarriage; and sudden death of seemingly fit people from stroke or cardiac arrest.<sup>43</sup>

Consistent with the publicly-declared transhumanist agenda, it looks like the deliberate weakening of people’s immune systems by “vaccine” is to prevent rejection of the “vaccine” contents. On this point, some of the people (e.g. Anthony Fauci) who pushed the “vaccine” are connected to HIV/AIDS research.<sup>34</sup> As was shown above under Deception, a Bulletin of the WHO fifty years ago records their intention to study virus-induced immunodepression.

Self-evidently, our attackers do not care about maiming and murdering people in their pursuit of transhumanist / New World Order goals.

## **Blood of young people**

Wealthy older individuals are transfusing the blood of young people into themselves to reverse ageing and extend their lives. For example, there is the case of a 55 year-old American billionaire reportedly paying \$40,000 per quarter to get infusions of blood from an 18 year-old person.<sup>29</sup> The subject of regenerative medicine and young blood is discussed in Aliens 4.

## **Hybrid monsters**

Genetic engineering includes cloning and the creation of hybrid monsters (chimeras), e.g. in 2019 it was reported that an international team of researchers created embryos containing both human and monkey cells and that their aim was to grow viable organs in chimeras for transplantation into humans.<sup>34</sup> Earlier known examples of genetic engineering include goats that produce spider silk in their milk, mice that sing and tweet like birds, super salmon, banana vaccines, chicken-humans that lay eggs with cancer-fighting proteins, cows that make human milk, and human organs grown in pigs.<sup>31</sup>

## **6.2 The identity of our attackers**

It seems as if the Nephilim became the people we know as jews (the Cabal) who continue to stream consciousness from the darkest realms of beyond.

In his book *The Culture of Critique: An Evolutionary Analysis of Jewish Involvement in Twentieth-Century Intellectual and Political Movements* (2002),<sup>45</sup> Prof. Kevin MacDonald examined jewish involvement in subversive movements as a group survival strategy.

Other academics have also documented the identity of our attackers in their scholarly articles published on Prof. MacDonald's website, the Occidental Observer.<sup>46</sup> For example:

V. S. Solovyev (2021). *Vaccine Passports, White Terror and Political Control: Who's Behind It. And Why?*<sup>47</sup> The entire fake Covid "pandemic" and deadly "vaccination" operation is permeated with Israel state and commercial interests, ideology, and political ambition, and it was planned for decades. The 'code' that activated the Covid "pandemic" / "vaccination" attack stems from ethno-religious and cooperative special interests.

Scott Howard (2021). *A Look Behind the COVID-19 Vaccine Curtain: Integration with Global Elites.*<sup>48</sup> Jews and Israel-based entities are dominant in the authoritarian control over citizenry via the fake Covid "pandemic" and toxic "vaccination."

Karl Haemers (2021). *The not-so-friendly folks at the World Economic Forum.*<sup>49</sup> The World Economic Forum (WEF) is perhaps the most influential global organization. The stated WEF agenda includes "resetting" humanity into a "fusion" of our physical, digital and biological identities, i.e. the WEF is instrumental in trying to establish the New World Order (brutal world government by jews). The WEF is led by a Board of Trustees and they are jews and philo-Semites. The WEF Board includes powerful jews such as Larry Fink, Mark Benioff, David Rubenstein, Leo Reif, and Executive Director Klaus Schwab himself, through his jewish mother.

Gunnar Alfredsson (2022). *Canada Under Globalist Control.*<sup>50</sup> WEF Executive Director Klaus Schwab boasted that the WEF has "infiltrated" governments all over the world, including Russia — according to Schwab, Vladimir Putin was a Young Global Leader of the WEF.

## 6.3 The psychology of our attackers

This is addressed in the post [Psychopaths](#). The Ego-centrism diagnostic criterion is illustrated in the statements of an attacker, quoted in an article by Karl Haemers

(2022):<sup>33</sup>

In his 2020 address to the WEF, Israeli jew Yuval Noah Harari stated “. . . AI and biotechnology will give us god-like abilities to re-engineer life, and even to create completely new life forms,” “Our intelligent design is going to be the new driving force of the evolution of life. In using our new divine powers of creation, we might make mistakes on a cosmic scale.”

Karl Haemers notes that (a) Harari’s replacement of God with the technocratic “elites” (including Harari) is a distinctly Judaic concept, and (b) the arrogance and anti-social intent of Harari and his ilk are extremely dangerous to the rest of us.

For more information about the attackers and their attack, I recommend “Review: The Perversion of Normality”<sup>51</sup> by Andrew Joyce, Ph.D. (2021) and “Facial, Racial, Spatial: How Human Faces and Brains Have Taken Different Routes through Race-Space”<sup>52</sup> by Tobias Langdon (2022).

## 6.4 Our attackers’ inevitable failure

The gangsters’ foolish pursuit of Divine power (e.g. artificially elevating themselves, degrading the rest of us, controlling the world, pretending to be God) will fail spectacularly. Hubris (illusory superiority) kills. A fundamental step in effective coping is realistic appraisal of the situation and one’s coping resources. Although our attackers think of themselves as gods, they are not gods and unlike gods and normal people, they do not learn from their mistakes. Jews seem to have learned nothing from their 1,030 expulsions for outrageous criminality (information and references in Aliens 4). Already we can see signs of the transhumanist / New World Order project unravelling, rage against our attackers growing, and the offenders heading for an unhappy ending.

In contrast to these destructive pretenders, the Anunnaki (truly advanced) respect the universal processes of which they are part (this is shown in their natural / pagan religion) and used their powers constructively (they created and civilized humans).

## 6.5 The link between transhumanism and ETs

Evidence presented in Aliens 4 indicates that most of the ET-type mutilation killings are done by the government and that the motives for these crimes include the transhumanist (New World Order / brutal world government by jews) agenda.

## 7. Summary of main points

1. Historical, scientific and biological evidence strongly indicates that Anunnaki ETs created human and other life.
2. The Anunnaki are good ETs in that they created and civilized us.
3. Anunnaki religion is natural, i.e. pagan.
4. There is abundant historical evidence of other ET species on Earth, although it seems that the Nommo could be the Anunnaki.
5. In both ancient Sumerian and biblical texts, the Nephilim (early ET x human hybrids) are portrayed as bad — destructive rulers who enslaved and exploited humankind.
6. The Starchild skull seems to be of a Grey ET and the Paracas skulls are likely of Nephilim and Nephilim x human hybrids.

8. In particular, transhumanism is an attempt to degrade, cull and control us.

# Aliens 2: Alien spacecraft encounters

It took many years for humans to develop anti-gravity craft based on ET technology acquired as of the 1947 Roswell ET spacecraft crashes when humans deliberately interfered with the crafts' navigation / propulsion systems by means of radar. As is noted in the post Aliens 3, flying disc simulators for training human pilots to fly ET-type craft started operating in the early 1960s and test flights of ET-type craft started in the 1980s. As a firm date reference, it seems that the first recorded sighting of a man-made ET-type craft might have been the craft seen in Rendlesham Forest (UK) on 26 and 27 December 1980.<sup>1,2</sup>

Therefore it seems safe to assume that any ET-type craft seen before 1980 were of ET origin and controlled by ETs. With careful evaluation of subsequent ET-type craft

sightings it should be possible to exclude most / all man-made anti-gravity craft sightings and continue focusing on genuine ET craft sightings as I have tried to do.

## 1. Twenty-five examples of ET craft encounters

Following are the main points of 25 incidents from the above-mentioned list of 145 such events. A link to the full list (includes links to source material and photographs / video) is in the Appendix. The 25 example cases are presented below in date order.

### 1. USA, 25 February 1942

In the early morning of 25 February 1942, suddenly out of nowhere, a huge object of unknown origin levelled off at a lower altitude. The object continued on a trajectory east toward the city of Los Angeles at ultra high speed, barely skimming the water. The object reduced it's speed to a near crawl some 50 miles out, turning inland near Point Dume. The air raid warning system regional controller ordered the anti-aircraft batteries to go to Green Alert — "ready to fire." At 2:15 am the controller ordered the whole warning system into operation. At 3:06 am, at least four Santa Monica area anti-aircraft batteries turned inland and started firing over the city and Baldwin Hills. Suddenly "the air over Los Angeles erupted like a volcano." For the next three hours it was nothing but confusion with swarms of planes of all possible sizes reported, numbering from one to several hundred, travelling at altitudes from a few thousand feet to more than 20,000, and flying at speeds from very slow to hundreds of miles per hour.

However, despite the fact that 1,440 rounds of anti-aircraft ammunition had been expended, the UFO seemed impervious to the barrage and it eventually left with no sign of damage.

### 2. Indonesia, 10 August 1944

Shortly after midnight on 10 August 1944, Captain Alvah M. Reida of the 486th Bomb Group, 792nd Squadron, was flying a B-29 Bomber from Ceylon to Palembang. The right gunner and copilot reported a bright red or orange spherical object pacing the plane about 500 yards off the starboard wing. It was about 5 or 6 feet in diameter and seemed to vibrate constantly. Captain Reida attempted evasive action, but the object followed every manoeuvre for about eight minutes, then suddenly made an abrupt 90 degree turn and accelerated away rapidly.

Note: This type of UFO was often seen by Allied aircraft pilots during World War II. It was referred to as a Foo Fighter. Military censorship kept reports of these phenomena out of the newspapers until December 1944.

### 3. India, 15 March 1951

At 10:20 am in New Delhi, members of a flying club, including the chief aerial engineer George F. Floate, witnessed a swirly white cloud appear in the sky from north to south at about 4,000 feet. The cloud was about 700 feet long and increasing in length. At the end of it a metallic cigar-shaped object about 100 feet long (about the size of a C-47 fuselage) appeared. The object was seen by 25 flying club members.

It headed south for about three minutes and then made a loop, coming back over the airfield. At the top of the loop it was out of sight but came back into sight during the dive. The object left a white exhaust which turned black when it accelerated to about 1,000 mph during the loop. After recovering straight and level flight, the object proceeded to the south-west until out of sight. It was observed for a total time of about seven minutes.

### 4. UK, 21 October 1952

In the afternoon of 21 October 1952, RAF pilots Flt Lt Michael Swiney and Lt David Crofts, in a Gloster Meteor, saw three white disc-shaped objects at 35,000 feet near RAF Little Rissington, a base in eastern Gloucestershire. The pilots noted that the shape of the saucer shape was perfectly circular. Flt Lt Swiney reported the sighting of the three saucer objects to his Ground Control at RAF Sopley and abruptly cancelled the training flight. Lt Crofts asked whether to pursue the three objects, but Flt Lt Swiney declined. The three objects crossed over the Meteor's path, from left to right and remained on that side. In a fraction of a second, the objects disappeared.

ATCC Gloucester (RAF Staverton, now Gloucestershire Airport) confirmed the three objects that the pilots had seen. Two Meteor F.8 aircraft of RAF Fighter Command were scrambled to intercept the objects but the fighter aircraft did not make contact with the objects. The RAF Southern Sector, based in Wiltshire, had detected three objects entering their airspace at 3,000 mph.

### 5. Papua New Guinea, 23 August 1953

At about 11:00 am on 23 August 1953, Port Moresby, T. P. Drury (Deputy Minister of Civil Aviation) and his wife noticed a wisp of a cloud suddenly appear in the blue sky from nowhere and rapidly build up into a thick white mass of cumulus. There were no other clouds in the sky and there seemed nothing to account for it. Drury filmed this event and what happened next.

Suddenly, an object like a silver dart shot out of the cloud. It was elongated in shape like a bullet. It was very clear-cut, sharp in front but apparently truncated behind, though the tail may have been hidden by the vapour trail. No wings or fins were visible. It shot out of the cloud upwards at an angle of about 45 degrees and was

travelling at least five times as fast as a jet plane travelling at the speed of sound. It never slackened speed or changed direction, but simply faded upwards into the blue and its vapour faded after it. The vapour trail was very clear, dense, white and billowing. In spite of the supersonic speed and nearness of the object, there was no sound whatever.

Air Traffic Control at Jackson's Airport could not explain the sighting in terms of known aircraft and the RAAF was also unable to account for it. Drury's film was later sent all over the world but no-one could explain the object.

#### 6. France, 10 September 1954

At about 22:30 on the night of 10 September 1954, railway worker Marius Dewilde went outside to investigate the reason for his dog's barking. He walked to the nearby railway tracks, where he saw an object about six or seven metres away from him and two small humanoid figures. Suddenly the object emitted a light beam that paralysed him. He then saw a door open in the object, the two beings board it, and the craft rise toward the sky while changing its colours.

When he recovered from the paralysis, Dewilde went home and told his wife and then his neighbour about what he had just witnessed. He then informed the local police and police officers visited his home. Upon approach to the incident location, Dewilde became sick and could not proceed further. Also, objects which are energized by battery, like Dewilde's flashlight and telephone, stopped working.

The following day, as people investigated the incident scene, an approaching train produced a very loud noise as it passed by, causing the train to stop. A six-metre depression was found on the exact spot where the object had landed and this had caused the noise. Also, the small rocks under the train tracks were all carbonized on the depression and the sleepers between the steel lines featured symmetric marks.

Following the incident, three cows in nearby farms were found dead. Autopsies on the animals revealed that their blood had been totally removed. Several local people claimed sightings of objects and creatures similar to the ones witnessed by Dewilde. Dewilde suffered respiratory problems after the incident and his dog died three days after exposure to the ET craft.

#### 7. Italy, 28 October 1954

On 27 October 1954, UFOs stopped a professional football match just after half-time in front of ten-thousand fans at Stadio Artemi Franchi, Florence. The spectators stopped watching the match and the footballers stopped playing. Everyone looked up at objects shaped like Cuban cigars moving across the sky. They were dropping what

was variously described as similar to silver glitter, cotton wool or cobwebs and angel hair. The newspaper La Nazione referred to this substance as glass fibres. After a short period of time the material disintegrated, e.g. a 10 year-old boy described seeing the roofs of houses in Florence covered in this white substance for one hour in broad daylight and then the substance seemed to evaporate.

Also, the substance disintegrated on contact and was therefore hard to collect. However Giorgio Batini, a journalist at La Nazione, and other people, managed to gather samples of the material. They took the samples to the Institute of Chemical Analysis at the University of Florence. The laboratory (led by respected scientist Prof Giovanni Canneri) subjected the material to spectrographic analysis and concluded that it contained the elements boron, silicon, calcium and magnesium, and that it was not radioactive.

There were numerous UFO sightings in many towns across Tuscany that day and over the days that followed.

#### 8. UK, 17 July 1955

On 17 July 1955 at noon, in Bexleyheath in London, a 30 foot-wide saucer-shaped object was seen hovering a few feet above a street in broad daylight by Margaret Fry and her doctor. Car engines near the object stalled. The aircraft made a humming noise. It landed at the junction of Ashbourne Road and Whitfield Road, hovered over Bedonwell Primary School (now Bedonwell Junior School) for about one minute, and finally shot off into the sky. The object was seen by about thirty people. Another UFO landed a few streets away at the same time. A similar object was seen in Bexleyheath in 1952.

#### 9. UK, 13 August 1956

On a dry and largely clear night, USAF radar picked up 12 to 15 objects over East Anglia. One object was tracked at more than 4,000 mph by USAF GCA radar at RAF Bentwaters. The objects sometimes travelled in formation, then converged to form a larger object and performed sharp turns. One object was tracked for 26 miles. It hovered for five minutes then flew off. At 10 pm an object was tracked at 12,000 mph. RAF de Havilland Venoms from RAF Waterbeach had sightings of the objects and ground personnel at Lakenheath made visual sightings of several luminous objects, including two which arrived, made a sharp change in course, and appeared to merge before moving off.

The sequence of events is recorded in the original Project Blue Book file by the USAF, subsequently analysed by the Condon Committee and by atmospheric physicist James E. McDonald. The final phase of the incident was described in some detail by

Technical Sergeant Forrest Perkins, who was the Watch Supervisor in the Lakenheath Radar Air Traffic Control centre and who wrote directly to the Condon Committee in 1968.

#### 10. Argentina, 1 December 1965

Staff at the Adhara Observatory photographed the moon in fixed intervals. Some photos revealed disc-shaped objects flying in front of the moon.

#### 11. Canada, 4 October 1967

On the night of 4 October 1967, several people saw orange lights over the sea near the small fishing village Shag Harbour and one of the lights went into the water. Royal Canadian Mounted Police Constable Ron Pound investigated and also saw the lights. Pound saw a yellow light slowly moving on the water, leaving a yellowish foam in its wake. Fishermen on boats saw the lights and at close range they confirmed that one of the objects left a yellow foam in its wake.

For several days thereafter, divers from HMCS Granby (a minesweeper in the Royal Canadian Navy) searched the bottom of the ocean where the incident occurred. Their findings were not released but the following is known: The object was detected with hydrophones and naval vessels were positioned over it, after entering the waters of Shag Harbour the object travelled underwater for about 25 miles to a place called Government Point (near a top-secret NATO submarine detection base), after a few days a second USO (unidentified submerged object) joined the first, the second craft assisted the original USO, and eventually the two underwater craft surfaced and flew away.

#### 12. Finland, 12 April 1969

Two pilots in Pori, Finland, named Jouko Kuronen and Tarmo Tukeya reported seven plate-shaped objects in a formation that flew at "ällistytävällä" (incredible) speeds. The objects were later detected via radar nearly 200 kilometers away in Vaasa. This sighting was acknowledged by the Finnish Air Force and published in Ruotuväki (2012), the Finnish Defense Forces' magazine.

#### 13. South Africa, 26 June 1971

Bennie Smit, owner of Braeside farm near Fort Beaufort in the eastern Cape, fired shots at an unknown object during the morning of 26 June 1971. He was alerted to it by his labourer, Boer de Klerk, who at 9:00 noticed a fireball of some 2.5 feet (0.76 m) in diameter, moving about at treetop height. Smit accurately fired eight shots at it, but these had no visible effect. The object reacted to their presence by moving away.

Police sergeant Piet Kitching and police station commander P. R. van Rensburg

arrived at 10:00 and fired additional shots. They stated that the object had been changing its colour up to this point, but now assumed the appearance of a gunmetal grey, and was somewhat like an oval-shaped 44-gallon drum. When Smit fired two final shots from a mere 10 to 18 m distance, the object lifted off, entering impenetrable woods where it could be heard crashing through the undergrowth. Smit had a final sighting after 12 noon, but subsequently heard its sound at night. Six council members at Fort Beaufort also reported watching the object through binoculars. Three sets of three imprints of its supposed landing gear were found in hard clay. The Grahamstown army regiment was said to have investigated the site.

#### 14. Italy, 30 November 1973

Pilot Riccardo Marano was about to land at Caselle Airport, Turin, in a Piper Navajo, when the controller notified him that there was a UFO about 400 meters (1,320 feet) above the runway. He looked and saw a luminous, multicoloured ball of light changing from violet to blue to dark red. "When I got closer and had a better view," he said, "the object at once made off, flying in a most irregular fashion, manoeuvring in a way I have seen no plane do, making fantastic lateral deviations, and sudden vast jumps to and fro, as if it enjoyed playing hide-and-seek. Its speed was as high as 900 km per hour (540 mph)."

The UFO was also seen by (a) Col. Rustichelli (commandant of the Caselle military airfield) on his own radar screen ("It was something solid, lit up, like a plane on my radar"), (b) Commander Tranquillo, pilot of an Alitalia Air Line DC-9 en route from Turin to Rome (he called to the control tower: "I see a shining thing giving out intermittent flashes of light, four miles from me. I dare not approach. I give way.") and (c) Commander Mezzalami (in another Alitalia DC-9, "I was able to observe the object — notified by the control tower just as I was about to touch down. I had a good view of it.").

#### 15. Canada, 13 May 1975

"Charlie Red Star" was a glowing red plasma-looking ball seen by hundreds of people on many occasions. A firm date given for one of these sightings is 13 May 1975. The object visited a small town called Carman, Manitoba, almost every night in 1975. Winnipeg TV station captured footage of Charlie Red Star and Grant Cameron (author of *Charlies Red Star: True Reports of One of North America's Biggest UFO Sightings*) witnessed Charlie Red Star multiple times at night, including a very close encounter when the red ball flew in front of his car.

According to Cameron, the UFO encounters may be related to ballistic missiles that were secretly installed in that area at the beginning of 1975, because after the weapons were removed in November 1975, the Charlie Red Star visits stopped.

#### 16. Canada, 26 October 1978

Twelve people in Clarendville saw a UFO in the early morning. The object was oval-shaped with a fin on its tail and had blue, red and yellow flashing lights. The craft emitted no sound. The Royal Canadian Mounted Police were called and then Constable James Blackwood witnessed the UFO hover about 100 feet (30.5 m) above the water for about two hours before leaving at the speed of a shooting star. Blackwood used a telescope specialized for drug surveillance to observe the UFO and other eyewitnesses used binoculars. When Blackwood flicked on his car's flashing blue and red lights, the object in the sky reacted by imitating the pattern of flashing lights.

In addition to the eyewitness reports, this object was tracked by the Department of National Defense, Gander, NF.

#### 17. Korea, 31 March 1980

On 31 March 1980 four Korean pilots were given orders to chase an Unidentified Flying Object. Korean Air Vice Marshal Im Byungsun spoke of closely witnessing an object flying at a trajectory that was rendered impossible by the limits of man-made technology. He stated, "The Unidentified Flying Object was disc-shaped and as big as three McDonnell Douglas F-4 Phantom IIs. It was strongly emitting sparks and lights from the core. The colour was similar to what one would see in oxy-fuel welding." The sighting was further corroborated by Air Force colonel Lee Seungbae and Air force colonel Park Osang.

#### 18. France, 8 January 1981

At about 5 pm on the afternoon of 8 January 1981, while working on his farm in the Var region of south-eastern France, a man called Nicolai heard a faint whistling. He then saw a device in the air at the height of a big pine tree at the edge of the property. The device landed with the impact of a boulder hitting the ground (it was later determined that the ground had been compressed by a pressure of about 4 or 5 tons). Then it took off, tilted, and travelled at lightning speed toward the north-east.

Nicolai was only about 30 metres from the landed craft and described it in detail: the shape of two saucers, one inverted on top of the other, a ridge all the way around its circumference; 1.5 metres in height; the colour of lead; and underneath were what looked like two circular trapdoors and two reactors or feet which extended about 20 cm below the body. After the object left, Nicolai went to the landing spot and noticed a circle about two metres in diameter. At certain places along the circumference of the circle were traces like abrasions.

Physical traces left on the ground were collected by the Gendarmerie within 24 hours

and later analysed in several French government laboratories. Extensive evidence of anomalous activity was detected. GEPAN (a department of the French Space Agency responsible for the investigation of UFO reports) also reconstructed the trajectory and duration.

Scientific analysis of the circular trace revealed that it was 2.4 metres in diameter in the form of a 0.2 metre wide ring, lighter in colour than the surrounding dirt, and formed by an extremely localized force applied in a nearly circular pattern. Also, analysis of resident alfalfa near the landing site showed chlorophyll levels between 30% and 50% lower than expected.

#### 19. Indonesia, 27 August 1992

A UFO passed over Ngurah Rai Airport on 27 August 1992. It was first spotted by Japanese people Masumisan and Mamisun at 7:15 pm. The UFO was then witnessed by the entire group of Japanese tourists along with Prayogo, Executive Director of Equator Divepro. The UFO was flat and seen swinging in the air with four bright yellowish lights. Two were brightly glowing above and two below. The object disappeared from view after four minutes. All the tourists' cameras and video recorders jammed during this incident.

#### 20. South Africa, 30 March 1995

This incident was documented in the 2 April 1995 edition of the Afrikaanse Sonntagszeitung Rapport newspaper. At about 8:30 am on 30 March 1995 in the Groot Marico region of Transvaal, 45 year-old farmer Jan Pienaar was driving his truck on a remote country road. The engine of his truck came to an abrupt halt. He then saw a strange disc-shaped object overhead with what he thought was a hole in its hull. He continued watching the vehicle as it landed at the roadside, eventually resting on three landing pods. The craft covered almost the entire road and seemed to be almost 10 metres high. Pienaar described the craft as translucent and lustrous, as though it was fabricated from a type of stainless steel, in the shape of two inverted soup plates with a pudding bowl on top. He also noted that the craft had several windows or portholes, its hull was lit up by a red-violet-green-yellow glow, and it emitted a strange buzzing sound.

Pienaar exited the truck with the intention of walking toward the object. However he found himself stuck to the spot and unable to move for almost five minutes. He said that it felt as though a magnet held him to the spot.

Suddenly the craft rose vertically into the air, slowly at first and then at the speed of lightning. Pienaar was then able to start his truck engine and drive to a nearby farm from where he reported the incident to the police. The police told him that they had

received several reports of sightings of a similar object the previous evening in multiple locations in the region.

Pienaar and another farmer, Chap Smit, then drove back to the spot where he had seen the strange craft. Upon arrival they noticed that the ground was much too hot to touch and that there was a chloroform-like odour in the area.

## 21. Brazil, 5 October 1996

While flying in his own plane, at 10:15 am businessman Haroldo Westendorff encountered a huge unidentified aerial object. He flew his aircraft very close to the object and observed it for more than ten minutes. The object had a base the size of a football stadium (about 100 metres in diameter), was 50 to 60 metres high, and shaped like a cone with eight corners. Suddenly the top of the UFO opened, a flying saucer exited vertically, the saucer tilted at 45 degrees and then it shot upward at great speed.

In response to Westendorff's radio report while flying around the UFO, Airton Mendes da Silva (Infraero operator in the control room of the Empresa Brasileira de Infra-Estrutura Airport) and his assistants Gilberto Martins dos Santos and Jorge Renato S. Dutra went outside and saw the object in the East sector towards runway 15/33.

## 22. USA, 7 November 2006

At approximately 16:15 CST on 7 November 2006, federal authorities at Chicago O'Hare International Airport received a report that twelve airport employees were witnessing a metallic, saucer-shaped craft hovering over Gate C-17. The object was first spotted by a ramp employee who was pushing back United Airlines Flight 446. The employee told Flight 446's crew of the object above their aircraft. The object was also witnessed by pilots, airline management and mechanics. No air traffic controllers saw the object and it did not show up on radar. The disc was visible for about five minutes.

Witnesses described the object as completely silent, 6 to 24 feet (1.8 to 7.3 m) in diameter and dark grey in colour. Several independent witnesses outside the airport also saw the object. One described a disc-shaped craft hovering over the airport and said it shot through the clouds at high velocity, leaving a clear blue hole in the cloud layer.

The National Aviation Reporting Center on Anomalous Phenomena (NARCAP) published a 155-page report on the sighting and called for a government inquiry and improved energy-sensing technologies: "Anytime an airborne object can hover for

several minutes over a busy airport but not be registered on radar or seen visually from the control tower, constitutes a potential threat to flight safety.”

### 23. Mexico, 2 May 2009

At about 5:15 pm on 2 May 2009, in daylight against a blue sky in the Valle Dorado area, Pedro Hernandez filmed a yellowish, jelly-like object releasing about 20 to 30 smaller objects along a horizontal axis running to the left and to the right of the object. The film was aired on Mexican TV in May 2009.

Some weeks later, another film of the same event emerged. It was shot by Alfredo Carrillo, who was clearly on the other side of the object. Hernandez’s film was shot with the sun reflecting off the object, whereas Carrillo’s film was shot looking more in the direction of the sun, i.e. the objects appeared more as silhouettes.

### 24. USA, 20 January 2015

Videos filmed by Navy pilots show two encounters with flying objects. One was captured by a plane’s camera off the coast of Jacksonville, Florida on 20 January 2015. The footage shows an object tilting like a spinning top moving against the wind. A pilot refers to a fleet of objects. The second video was taken a few weeks later. The objects persisted, showing up at 30,000 feet, 20,000 feet, even sea level. They could accelerate, slow down and then hit hypersonic speeds. Lieutenant Accoin said he interacted twice with the objects. The first time, after picking up the object on his radar, he set his plane to merge with it, flying 1,000 feet below it. He said he should have been able to see it with his helmet camera but could not, even though his radar told him it was there.

A few days later, Lieutenant Accoin said a training missile on his jet locked on the object and his infrared camera also picked it up. However, “I could not pick it up visually.” The pilots said that the video showed objects accelerating to hypersonic speed, making sudden stops and instantaneous turns — something beyond the physical limits of a human crew.

### 25. USA, 21 February 2021

Shortly after noon, **2. Lunar factors in ET craft sightings** both Andrew Johnson and RichPlanet TV have noted that ET craft activity seems correlated to the availability of energy from the natural environment. On page 29 of his book *Acknowledged: A perspective on UFOs, Aliens and Crop Circles* (2019) Andrew Johnson discusses a video (now uploaded from a NASA shuttle) of what seems to be intelligently-controlled craft manoeuvring in the upper atmosphere and interacting with thunderstorms. Focusing on a different source of energy, in a RichPlanet TV

video (2017) Richard Hall<sup>3</sup> features an ET craft videoed hovering over a mountain in Wales and notes the possibility of lunar factors associated with ET craft activity in relation to their use of telluric current. Telluric current, also known as Earth current, is electrical current that travels over large areas at or near the surface of Earth.<sup>4</sup> According to Santos et al. (2011),<sup>5</sup> the telluric field does indeed oscillate according to tides (forces of the Moon cause sea levels to rise and fall) and the telluric field induced by tides spreads out far inland. Similarly, Kolvankar et al. (2010)<sup>6</sup> found that earthquake counts go up steadily from apogee to perigee and also toward full Moon. Greater numbers of major earthquakes occur when perigee coincides with full Moon and new Moon than at apogee with similar combination.

On the basis of the above, I analysed the dates of the 145 ET craft encounters in relation to phases of the Moon and the Moon's perigee – apogee cycle. The online Lunar Perigee and Apogee Calculator<sup>7</sup> was used to determine perigee and apogee dates and times, Calendar-12.com<sup>8</sup> was used to determine Moon phases, and the online Chi-Square Calculator for Goodness of Fit at Social Science Statistics<sup>9</sup> was used to calculate the statistics.

## 2.1 Findings



ET craft sightings: Lunar cycle and phase




Figure 1a. No. of ET craft sightings per day across lunar cycle.


Figure 1b. No. of ET craft sightings per lunar phase.

In Figure 1a light blue shading demarcates the lunar phases. Notable features of this chart: a spike in ET craft sightings at the start of Last Quarter (LQ), after which the number of cases tails off until the end of New Moon (NM).

Figure 1b shows the relatively high number of sightings during Last Quarter. Yellow shading highlights the difference between First Quarter (the phase with fewest cases) and Last Quarter (the phase with most cases). The Chi<sup>2</sup> value for the difference between these two phases is 3.753. The p-value is .05271, i.e. almost significant at  $p < .05$ . This finding indicates that ET craft sightings were more likely to occur during Last Quarter than First Quarter. The next biggest difference between lunar phases (Last Quarter – New Moon, Chi<sup>2</sup> value 2.45, p-value .11752) is notable but not significant at  $p < .05$ .

Summary: ET craft sightings by lunar phase

Most ET craft sightings occurred during Last Quarter. The difference between the number of cases during First Quarter (fewest cases) and Last Quarter (most cases) was almost significant at  $p < .05$ .



ET craft sightings: Perigee-apogee cycle and lunar phase




Figure 2a. No. of ET craft sightings per day across perigee-apogee cycle.

In Figure 2a light blue shading demarcates the cases that occurred closer to perigee from those that occurred closer to apogee. Notable feature of this chart: More cases occurred closer to apogee than closer to perigee. The  $\chi^2$  value for the difference between these two groups is 3.648. The p-value is .05613. The difference is almost

significant at  $p < .05$ .

In Figure 2b yellow shading highlights differences between certain lunar phase and perigee-apogee categories. The  $\chi^2$  and p-values for the difference between these groups:

Last Quarter with the Moon closer to Perigee vs Last Quarter with the Moon closer to Apogee ( $\chi^2$  value 1.723, p-value .18926). This difference is not significant at  $p < .05$ .

Last Quarter with the Moon closer to Apogee vs New Moon with the Moon closer to Perigee ( $\chi^2$  value 7.41, p-value .00649). This difference is significant at  $p < .01$ . The finding indicates that ET craft encounters were more likely to occur during Last Quarter with the Moon closer to Apogee rather than during New Moon with the Moon closer to Perigee.

New Moon with the Moon closer to Perigee vs New Moon with the Moon closer to Apogee ( $\chi^2$  value 3.667, p-value .05551). This difference is almost significant at  $p < .05$ . The finding indicates that ET craft encounters were more likely to occur during New Moon when the Moon was closer to Apogee rather than Perigee.

Summary: Perigee-apogee and lunar phase findings

There was a tendency for the ET craft to be seen when the Moon was further from Earth (closer to Apogee), particularly during Last Quarter and New Moon.

Consistency of findings




Figure 3. No. of ET craft sightings by lunar phase and closest point (perigee or apogee) in perigee-apogee cycle: Pre-1970, Pre-1990, All cases.

In order to assess the consistency of these findings across time, I separately analysed

the incidents that occurred pre-1970 (58 cases) and pre-1990 (95 cases). The distribution of Pre-1970 cases (when there were no ET-type craft flown by humans) shows the surge in ET craft sightings when the Moon was further from Earth (closer to Apogee) during Last Quarter and to a lesser extent at New Moon. Similarly, the distribution of Pre-1990 cases (when the risk of including a case of human-controlled anti-gravity craft in the 1970 to 1989 period was present but low) shows the surge in ET craft sightings when the Moon was further from Earth during Last Quarter and to a lesser extent at New Moon, a profile that persists in the distribution of all 145 cases. The consistency of these findings indicates that this Apogee factor is associated with ET craft.

Chi<sup>2</sup> and p-values for the differences highlighted in yellow:

#### Pre-1970

Last Quarter with the Moon closer to Perigee vs Last Quarter with the Moon closer to Apogee (Chi<sup>2</sup> value 2, p-value .1573). This difference is not significant at  $p < .05$ .

Last Quarter with the Moon closer to Apogee vs New Moon with the Moon closer to Perigee (Chi<sup>2</sup> value 2.882, p-value .08956). Although this difference is not significant at  $p < .05$ , it approaches significance at that level.

New Moon with the Moon closer to Perigee vs New Moon with the Moon closer to Apogee (Chi<sup>2</sup> value 0.692, p-value .40538). This difference is not significant at  $p < .05$ .

#### Pre-1990

Last Quarter with the Moon closer to Perigee vs Last Quarter with the Moon closer to Apogee (Chi<sup>2</sup> value 2.455, p-value .11719). This difference is not significant at  $p < .05$ .

Last Quarter with the Moon closer to Apogee vs New Moon with the Moon closer to Perigee (Chi<sup>2</sup> value 9.846, p-value .0017). This difference is significant at  $p < .01$ .

New Moon with the Moon closer to Perigee vs New Moon with the Moon closer to Apogee (Chi<sup>2</sup> value 3.556, p-value .05935). This difference is almost significant at  $p < .05$ .

#### Interpretation of the lunar findings

1. Lunar factors (especially lunar phase in combination with the perigee-apogee cycle) are significantly related to the dates of these ET craft sightings. The consistency of these findings over time supports the view that this Apogee factor is associated with ET craft activity and not man-made ET-type craft activity.
2. The lunar findings support the view of Richard Hall that ET craft activity is associated with lunar factors.
3. I am not in a position to do more than speculate about ETs' apparent preference for flying in the vicinity of Earth during Last Quarter (especially) and New Moon when the Moon is further from Earth. Perhaps the preference is due to higher levels of telluric current being available at those times or increased stability of the current due to reduced tidal range at apogee (the telluric field and tidal motion was referred to above in relation to Santos et al. 2011).

### 3. Technical aspects of ET craft operation

Bob Lazar (1959 — ) worked as a physicist at the S-4 facility (underground, inside the Papoose Mountains, near Area 51) for about six months as of early 1989. In an interview (1989)<sup>10</sup> he described the operation of the ET craft that he studied:

- It produces a gravity wave similar to the gravity wave Earth produces.
- The craft phase-shifts the wave so that it works against the natural gravity wave of the Earth and produces a lift effect.
- There are three amplifiers. The craft can operate on a single one to lift off the ground.
- Propulsion thereafter is by means of Omicron configuration, where the craft is using one generator or a Delta configuration where it's using all three for for space travel.
- For space travel, the craft tilts up on its side, focuses the three gravity generators to a single point, and essentially rolls down hill for infinity by chasing a little distortion.
- For the above reason, these craft behave strangely when flying at low speed near Earth because the gravity field of Earth is not constant and stable. Depending on the minerals and density of the earth underneath, the gravity will vary somewhat. Therefore you get odd movements of the craft. Low speed mode is relatively unstable.
- The ET craft produces no exhaust but there is a high voltage discharge from the craft. Therefore they appear as glowing balls of light in the night sky. Even close up you would see a glowing halo around the craft.
- The ET craft can be invisible because its gravitational field bends light. From underneath the craft and other vantage points, the viewer might only see what is above the craft.

- The ET craft is virtually noiseless, i.e. it is possible for the craft to be relatively close to a potential observer without being seen or heard.

In the same interview Bob Lazar stated the following about Element 115:

- It is a strictly extraterrestrial material. It is virtually impossible to make any usable quantity of such a heavy element on Earth.
- Element 115 is in the top of the reactor.
- At the base of the reactor is a particle accelerator. A particle accelerated to high speed is aimed at the 115. This causes a radiation of anti-matter that reacts with matter and converts to 100% heat energy.
- The heat energy is converted to electrical power by a thermal electric converter in the reactor.
- This electricity powers sub-systems on the craft.
- Bombarding the 115 also produces a gravitational wave at the top of the reactor.
- The gravitational wave is guided to an amplifying cavity and then through projectors that are in the bottom of the craft.
- As Element 115 is stable, it is not radioactive, i.e. it does not pose a radiation danger to the crew.
- At the time of the interview (1989) he understood that the military had acquired 500 lbs of Element 115.
- Possibly the military's Element 115 arrived in one of the ET craft.

## 4. The 145 ET craft encounters: Notable features

- Immobilization and disintegration. ETs can (a) immobilize / paralyze animals (including humans) and (b) neutralize the force holding objects together and potentially cause them to disintegrate.
- Invisibility. ETs can cloak their craft and render them invisible to the naked eye and radar.
- Electrical malfunction. Electrical devices can be rendered inoperative in the vicinity of ET craft.
- Resilience against human attack. In general (not always) ET craft do not seem to be affected by conventional weapons. However they can be brought down by radar / laser-type weapons.
- Defensive hostility. ET craft will potentially respond with hostility (e.g. destroying the aircraft and its occupants) when approached by human military aircraft. In contrast, ET craft can be (not always) tolerant of approach by civilian aircraft.
- Inadvertent harm to life. Close-range exposure to ET craft can result in serious biological harm, e.g. damage to plants, humans and other animals.
- Speed and maneuverability. Extreme speed and maneuverability of ET craft is

demonstrated.

- Water. ET craft can travel and remain underwater for many days at least.
- Size range. There is a wide range in ET craft sizes, from huge mother-ships to relatively small objects no bigger than a 44-gallon drum.
- Monitoring / intervention. In part ET craft seem to be present in places of human military activity, including preparation for war and war. There is also evidence of ET opposition to such activity.

## 5. Why are ET craft here?

The answer to this question likely varies somewhat according to the ET species in control of the craft. However in general the reason is likely the same as the reason for ETs' presence on Earth since before they created humans, i.e. (a) use of Earth's resources (mineral and biological), including the use of this planet as one of their homes / bases in our solar system and (b) management of Earth's resources, including (i) monitoring the state of Earth-based life (individual species and ecosystems) and (ii) intervention in ways that they consider beneficial to Earth and themselves, e.g. nudging an asteroid so that it strikes Earth to alter habitats and ecosystems, triggering volcanic eruptions to melt ice sheets and thereby change conditions on Earth, and genetic engineering to create new forms of life (including humans) that serve the ETs' goals.

## 6. Where do the ET craft come from?

According to authorities on this subject such as those cited below, the immediate origins of ET spacecraft seen in the vicinity of Earth are:

- Outer space — including mother ships in the vicinity of Earth.
- Bases on Earth — independent of human support (e.g. underground or underwater in remote parts of oceans) or dependent on human support (e.g. at military installations).

Support for independent ET bases on Earth is provided by cases such as these:

- An ET spacecraft was seen exiting a cavern system near the Russian border.<sup>11</sup>
- The crew of a Russian nuclear submarine in the South Pacific encountered a formation of six disc-shaped ET spacecraft at a depth of about 260 metres and travelling at over 265 miles per hour directly toward the submarine. After the submarine then surfaced, the spacecraft were seen leaving the water and flying away at extremely high speed.<sup>12</sup>

Evidence for ET bases on Earth that are dependent on human support is provided by sources such as these:

- Former naval intelligence officer William Cooper wrote<sup>13</sup> that the United States Government constructed underground bases in Utah, New Mexico, Arizona and Colorado for use by a certain ET nation (the Greys presumably).
- Similarly, on 29 August 2014, Linda Moulton Howe,<sup>14</sup> quoting from the book UFO Highway by Anthony F. Sanchez, stated the following on her website: There really is an underground ET cloning and hybridization lab near Dulce, New Mexico. The “Dulce Grey ET Facility” is allegedly underground Archuleta Mesa and Mt. Archuleta, New Mexico.
- In a RichPlanet TV documentary<sup>15</sup> Richard Hall refers to information about such a base within a mountain in Brecon Beacons, Wales.

## 7. Summary of main points

1. Many people, including highly credible witnesses, have seen ET craft near and on Earth and provided supporting evidence, e.g. video and radar.
2. Lunar factors (especially lunar phase in combination with the perigee-apogee cycle) were significantly related to the dates of these ET craft sightings.
3. For certain reasons, possibly related to availability of energy from the natural environment, ETs’ showed a preference for flying in the vicinity of Earth during Last Quarter (especially) and New Moon when the Moon was further from Earth (nearer apogee).
4. Technical and other aspects of ET craft were highlighted.
5. The purpose and origin of ET craft on Earth were discussed.
6. In particular, it was noted that some ET craft appear to originate from outer space while others seem to originate from bases on Earth, either independent of human support or dependent on human support.
7. At least in the USA, but perhaps more widely, Grey ETs are living on Earth with human support, i.e. they are in partnership with the Cabal.

The ETs were nothing like you would see in films. They looked like devils. They were not friendly and you would not approach one on your own. The ETs are extremely strong and powerful. They would rip you apart. You needed cover [an armed colleague] because they were so quick. They could move 60 metres in a split second. We saw three distinct types of ETs on our missions. In four or five of these cases we were able to say what had been aboard the craft. This included human and animal body parts. The largest number of human bodies secured in a single ET-craft incident was 24 human bodies in Australia.

Richard D. Hall (2015) reporting on testimony from a reliable military source whom he interviewed.<sup>1</sup> During the 1990s the military source served in a find and secure unit to cover up UFO cases and in particular mutilated human beings.<sup>1,2</sup>

## 1. ET Species in contact with Earth

The number of ET species said to be in contact with Earth during the human era varies across reports. Reasons for this variation include the extent to which (a) ET species are separated into sub-species (e.g. there seems to be many sub-species of Greys and Reptilians), (b) a distinction is made between ET observers' state of consciousness, i.e. was the ET seen during waking consciousness or perceived non-locally (ESP, dream, "channelling") and (c) ambiguity in interpreting ancient evidence

(written, art, oral) about the particular ET species seen on Earth, e.g. information in [Aliens 1](#) suggests that the Anunnaki and Nommo might be the same ET species.

Despite the challenges of listing ET species that have been in contact with Earth, there is no doubt about this: Most of these ET species are benevolent toward humans but two groups of ETs can be extremely aggressive toward us. As this post shows, (a) these two dangerous ET groups are some Reptilians and the Greys and (b) it is the psychopathic Greys who are collaborating with the psychopathic Cabal for psychopathic purposes.

Following is a list of nine ET types said<sup>3</sup> to be presently in contact with Earth.

## Greys

Grey ETs have been seen by many people in the modern era and their presence on Earth is shown in the ancient rock art of Australia and North America (referred to in [Aliens 1](#)). Greys were genetically engineered by the Reptilian ETs to be a slave race and come from the Zeta Reticuli binary star system, which is about 39.3 light-years away<sup>4</sup> Tall Greys are about 5 to 8 feet tall, the leaders and the most intelligent of the two Greys. They work in scientific areas such as genetic engineering. In particular, they are working to develop a stable Human x Grey hybrid race. Short Greys are about 3.5 to 4.5 feet tall. They have been cloned to work for the tall Greys, including mutilation killings. Noted physical features of Greys include grey skin tone; large heads; large dark eyes; long skinny fingers, arms and legs; small mouth; small ear holes; and two small nostrils. Both tall and short Greys are emotionless, place little value on human life and are cruel. Greys view us as their property — a source of genetic material to use for their own purposes.<sup>5,6,7</sup>

Reports of Grey ET sightings are presented below under Reported ET encounters.

## Nordics

Nordics (Tall Whites) seem to be the most human-like in appearance of all ETs, closely resemble people of Scandinavian descent, can pass as human, and are interested in the well-being of our species. They typically have blonde to reddish hair, blue or green eyes, stand 5 to 7 feet tall and live for about 600 to 800 Earth years. They first began appearing to contactees in the 1950s. Nordics claim to be from the planet Venus and later the Pleiades star cluster. However it is suspected that they might be keeping their true home a secret for security reasons.<sup>6,8</sup>

Reports of Nordic sightings are referred to below in relation to the The Greada Treaty.

A declassified document reveals that the US Government discovered an ET race on Mars in May 1984 via the remote viewing (non-local perception, sensing with the mind) of the esteemed remote viewer Joseph McMoneagle. In addition to other features of Mars such as huge dust storms, massive pyramids, megaliths, intersecting roads, and aqueducts, Joseph McMoneagle saw a group of tall and slender humanoids. He communicated with them telepathically and learned that the planet was experiencing cataclysmic events.<sup>9</sup> The description of these ETs seems to suggest that they were Nordics. Such close proximity of Nordics to Earth is consistent with Nordics' quick reaction to Grey ETs visit to Earth in 1953 and 1954 (discussed below under The Greeda Treaty).

## Reptilians

Alpha-Draconians are said to be the oldest known reptilian race in our galaxy, have colonies in Alpha Draconis, and were in contact with Earth even before the Anunnaki arrived here. Alpha-Draconians are known as muscular and extremely powerful. There are two types of these reptilians: a royal caste of giants and smaller ones (8 feet tall) that form a well-trained warrior class.<sup>5,8</sup>

Full-blood Alpha-Draconians are at the top of the reptilian hierarchy and maintain control over the hybrid reptilians. Reptilians are one of the most technologically advanced civilizations in the universe. In addition to creating hybrid reptilians, they also created the Grey ETs.<sup>8</sup>

At least some of the extremely powerful and aggressive ETs encountered by the military source quoted at the start of this post seem to have been reptilian. The only other ET species known to have been currently involved in ET-type mutilation killings on Earth is the Grey and the military man's description does not fit the physical characteristics of a Grey.

## Arcturians

They are the most ancient and wise ET species known to inhabit the Milky Way. It is suggested that the other ET species in our galaxy may have descended from them. Arcturians have mutated and evolved into many forms. The main race of Arcturians are about 5 feet tall with green skin and large eyes.<sup>6,8</sup>

## Sirians

The term Sirians refers to a abroad class of ETs that includes the Nommo and most likely the Anunnaki (who may even be the Nommo). It is said that the Sirians helped

to create the human race and they guided the early civilizations of Earth, including Atlantis, Lemuria, the Mayans, the Dogon tribe, and Egypt. ETs from the Sirius star system vary greatly. Some (mostly around Sirius A) are benevolent and good, others (mostly around Sirius B) are evil. Further, many of these ETs are humanoid, many are non-humanoid, some are reptilian, and some are aquatic like the Nommo. There are many Sirian ETs intent on helping Earth.<sup>5,8</sup>

## Pleiadians

They come from a star cluster known as the Pleiades, are closely related to humans genetically and are one of several ET species that look very similar to humans. However Pleiadians tend to lack pigmentation in their skin and hair, giving them an albino appearance. Like ETs more generally, they have strong non-local (extra-sensory) perception. In principle it should be relatively easy for humans high in ESP to establish mental contact with Pleiadians.<sup>6,8</sup>

## Yahyel

They are kind and loving and similar to humans in physical appearance with intense interest and affection for humans. They are also known for their advanced and harmonious relationship with technology. According to ET lore, Yahyel descend from the Lyrans family of races, as do humans, i.e. they are genetically related to us.<sup>6,8,10</sup>

## Sassani

They are a humanoid Reptilian x Grey x Human hybrid, common across the cosmos, and friendly toward us.<sup>6</sup> Sassani live on the planet Essassani, about 500 light-years from Earth near the Orion constellation. They have light greyish skin and enlarged eyes. They are helped by other ET races, including Pleiadians.<sup>5,8</sup>

## 1.1 Psycho-spiritual significance of star systems

It is notable that Anunnaki religion (natural, i.e. pagan, see [Aliens 1](#)) focuses on star systems associated with virtuous beings (like themselves) including a goddess, and they ignore star systems that are home to evil-doers. Specifically, the Anunnaki:

- Worship the Orion constellation (home of the Sassani), the Pleiades cluster (home of the Nordics and Pleiadians in general), and the Sirius star system (home of the Nommo and other Sirians, including the Anunnaki it seems).
- Worship the goddess of love, war, and fertility (Inanna), associated with the seven stars of the Pleiades star cluster.

- Ignore the Zeta Reticuli and Alpha Draconis star systems (home to the anti-social Greys and Reptilians respectively).

## Implications of Anunnaki expressed star / being preferences

The Anunnaki would be:

- Profoundly opposed to the anti-social Grey ETs and the Cabal associating with them.
- Profoundly opposed to the anti-social Reptilians.
- Fundamentally supportive of humans who share their values as represented by their goddess Inanna, i.e. they would want to help those who value love (for self, family, nation), war (righteous violence against attackers) and fertility (life). Evidence of Anunnaki support for people who share their values is presented below in relation to their help of National Socialist Germany.

The above point is consistent with what Wilbert Smith (1910-1962, M.Sc. Electrical Engineering, ET researcher and contactee) learned from pro-social ETs — They stand by ready, able and willing to help us, but they cannot help us until we are ready for their help. In other words, pro-social ETs can only help us when we share their values as represented by goddess Inanna (see the post [From ET to Enlightened Time](#) for more on what Wilbert Smith learned from ETs).

## 2. Reported ET encounters

### 2.1 The 145 ET-type spacecraft encounters (1825 – 2021)

Six of the 145 ET-type spacecraft encounters listed in the appendix of [Aliens 2](#) include descriptions of the craft's occupants (these cases can be found with a search on "humanoid"). Three of these descriptions are specific enough to suggest short Grey ETs:

10 September 1954, France. Two small humanoid figures were seen boarding a craft. The observer shone a torch at the beings. The light reflected off their heads as if they were wearing a reflective helmet. The observer was then paralysed by a beam emitted from the craft before it flew into the sky. Soon after this incident, three cows in nearby farms were found dead. Inexplicably, all their blood had been removed.

7 May 1989, Botswana. An alien craft was shot down by South African aircraft and two small humanoids captured. They were 4.5 feet high, had over-sized heads, slanted eyes, greyish blue skin, were completely hairless, and had scaly ribbed skin covering

their chests. The ETs were aggressive and scratched a doctor who wanted to examine them. They also refused to eat food that they were offered.

15 September 1995, Lesotho. An ET craft crashed in Lesotho and South African forces captured three live ETs that were onboard. They were described as humanoid with some reptilian aspects.

The remaining three ET encounter reports do not contain enough information to allow identification of the ET species:

23 February 1975, Japan. Two bright orange objects were seen in the sky. One of the objects landed and a silver-suited humanoid emerged.

4 February 1977, UK. A cigar-shaped aircraft landed and a silver-suited humanoid emerged. A week before this incident, in the same area, a saucer-shaped craft and silver-suited humanoids were seen.

27 September 1989, Russia. A red ball in the sky turned into a disc and landed. A silver-suited humanoid and a robot emerged from the craft.

See the list in the appendix of [Aliens 2](#) for more information about these six cases.

## 2.2 Credo Mutwa (1921 – 2020)

Vusamazulu Credo Mutwa was a Zulu traditional healer (sangoma) from South Africa who spoke and wrote about his encounters with ETs.<sup>11</sup> Following is information from Mutwa published in New Dawn (2008).<sup>12</sup>

He states that in 1958 he was abducted by Greys and taken to their base under the sacred Inyangani Mountains of Rhodesia. The beings were grey-skinned, short (African pygmy size), had very large heads, eyes like a cat (round with vertical pupils) behind their black goggle-like covers, very thin arms, very thin legs, and emitted a very unpleasant rotten eggs / sulphur odour. A taller figure in the group seemed to have authority over the others. He was paralysed and unable to flee. After surviving the abduction, Mutwa learned that he had been caught by the God of the mountains and was missing for three days.

### Mutwa on Grey ETs

- They are sinister, repulsive, selfish, parasitic, manipulative, use us, harvest things from us, power-hungry, sow discord and cause disease.

- Humanity suffers the negative influence of ETs, particularly the Greys.
- Zulus refer to Grey ETs as the mantindane (the tormentors) and Africans greatly fear the Greys.
- Grey ETs share Earth with us and should not be considered foreign.
- It would be better for us to acknowledge the presence and influence of Greys.

## 2.3 Bill Uhouse (1924 – 2009)

Bill Uhouse was a fighter pilot in the Marine Corps who subsequently worked on flight

simulators as a mechanical avionics engineer for 37 years as of 1954.<sup>14,15</sup> From 1958 to 1988 he worked specifically on “flying disc simulators” in which certain US Air Force pilots trained. The simulators were based on a 30-metre wide ET craft presented to the US government by ETs in 1953, in Kingman, Arizona. The craft was then taken to Area 51 and the four ETs on board went to Los Alamos National Laboratory in northern New Mexico for study by scientists. The difference between this aircraft and other discs that the US had examined was that this craft was a much simpler design. The first flying disc simulator was functional by about 1958 and it was put into operation as of about 1962 or 1963.

The technical advisor on the flying disc simulator project was a short Grey ET (about 4 feet 9 to 5 feet tall), originally from the Zeta Reticulum star system. This ET became known as J-Rod. He had been working with a secret agency of the US government since 1953 at Los Alamos National Laboratory and in a secret underground facility called Site 4 (S-4), which is inside the Pappoose Mountains near Groom Lake, Area 51 and Nellis AFB. In effect J-Rod was head of the flying saucer simulator project.<sup>14</sup>

At least two J-Rods were known to be working for the US at that time: one was located at Los Alamos National Laboratory and the other at S-4.<sup>14</sup>

From an interview<sup>15</sup> with Bill Uhouse in 2000:

ETs can actually speak. J-Rod spoke like a parrot and sounded human. However he might not understand a question unless it was put on paper and explained. J-Rod could answer questions that even our top mathematicians could not answer. J-Rod’s skin was pinkish and a little bit rough.

## 2.4 National Socialist Germany (1933 – 1945)

On several occasions, NASA director Dr. Wernher von Braun (a rocket scientist in Germany during World War II ) said that National Socialist Germany received help from ETs.<sup>16,17</sup> This claim is consistent with evidence concerning Maria Orsic. She was a famous medium and leader of the Vrili Society (a group of young female mediums) in Germany. Via non-local communication (ESP) she received information from ETs in Aldebaran, in the constellation of Taurus [the Pleiades star cluster is in the north-west of this constellation and — along with the Orion constellation and Sirius in the Canis Major constellation — the Pleiades star cluster is worshipped in Anunnaki religion]. They gave her information of a technical nature for the construction of a flying saucer. She wrote this information down in two languages, one that was legible and another that a group of Germans known as Pan-Babylonianists determined to be ancient Sumerian. A project to build a prototype of this flying apparatus began in 1922.<sup>18,19</sup>

This information is documented by respected academics: History professor Dr. Nicholas Goodrick-Clarke (2002)<sup>20</sup> and Retired History professor Dr. Raymond A. Keller (2017).<sup>21</sup>

Note: The connection of these ETs to both a star constellation (Taurus) and a language (ancient Sumerian) associated with the Anunnaki indicates that Maria Orsic was in contact with the Anunnaki.

## 2.5 Philip Schneider (1947 – 1996)

Philip Schneider worked on secret United States government projects for 17 years as a geologist and structural engineer. After resigning from his government post, he gave over 30 public lectures about what he had learned during the course of this work. In the References are links to two of these lectures, one in September 1995<sup>22</sup> and another in November 1995.<sup>23</sup> In these videos Mr. Schneider gives details of his personal encounter in late August 1979 with hostile seven feet tall Grey ETs that stank worse than the worst garbage can. This event occurred while Mr. Schneider worked on a secret underground facility in Dulce, New Mexico. Mr. Schneider shot two of the ETs dead but was severely injured by an ET when it emitted a blue beam, like a lightning bolt. His visible injuries include fingers burned off his left hand (clearly visible in the September 1995 video). I would recommend viewing the videos for more information about what was a major incident involving the deaths of many military personnel.

Understandably, some writers are sceptical of Mr. Schneider's claims. However, readers might want to bear this in mind:

### First-hand vs second-hand knowledge

We can distinguish between what Mr. Schneider claims to have personally experienced and information obtained from others. For example, Mr. Schneider repeats claims made about an ET named Valiant Thor. In contrast to the period in which Mr. Schneider was speaking, we can now easily use the Internet to find articles such as one in Skeptoid<sup>24</sup> that exposes this story as fabricated in 1967 by a dishonest Christian evangelist named Rev. Frank E. Stranges. Similarly, Mr. Schneider repeats anti-Hitler / National Socialist Germany lies. However, again, back in 1995 before we had ready online access to the truth of this subject, many of us were still fooled by Cabal lies about WW2 in which all sides lost (the only winner in this senseless slaughter was the psychopathic Cabal that orchestrated the entire conflict).

### He threatened the Cabal

Mr. Schneider's claim that his truth-telling threatened the Government and that they wanted to murder him are backed by facts. After he was found dead in his apartment

in January 1996, his ex-wife documented<sup>25</sup> facts that strongly indicate torture and murder (poisoning and violence) by the government. This suggests that Mr. Schneider was publicly speaking truth that threatened Cabal power and control. Concerning the Cabal's torture of Mr. Schneider, as is shown in Aliens 4, psychopathic hatred and sadism is a hallmark of the Talmudic alien.

### Motives

It is readily apparent from his lectures (especially the Sep 1995 talk<sup>22</sup>) that Mr. Schneider was devoted to speaking truth to the best of his knowledge and ability for the benefit of his people. For example, from the September 1995 talk:

- The present government rules over us like kings and queens over serfs.
- We have to get the message out.
- This country is not going to a New World Order.
- Our patriot movement will kick the parasites out!

Mr. Schneider's declaration expresses the love for our people, war against those who dare to attack us, and value of life that the Sumerian goddess Inanna stands for. In paganism as it subsequently developed in Europe, the psychic forces expressed via Mr. Schneider's statement are those of Odin, the god of inspiration, shamanry and battle.<sup>26</sup>

## 2.6 The Greeda Treaty (1954)

According to former naval intelligence officer William Cooper in Chapter 12 of his book *Behold a Pale Horse* (1991):<sup>27</sup>

Grey ETs visited Earth in 1953 and 1954

In 1953 astronomers discovered large objects heading toward Earth. Later evidence revealed that the objects could only be spaceships. The spaceships contained Grey ETs and took up a very high orbit around the equator. Through radio communications using the computer binary language, face-to-face contact with the ETs was arranged. Consequently during 1954 these Greys landed at Holloman Air Force Base for a meeting with President Eisenhower and others. At this meeting an agreement known as The Greeda Treaty was signed. According to William Cooper, the treaty included the following:

- We would keep their presence on Earth a secret.
- They would give us advanced technology and help us to develop technologically.
- They could abduct humans on a limited and periodic basis for scientific and medical purposes.

## Nordic ETs visited Earth in 1954

During the period referred to above, a race of human-looking ETs known as Nordics contacted the US Government. The Nordics warned us against the Grey ETs then orbiting the equator and offered to help us with our spiritual development. They refused to share their advanced technology with us, saying that we were not spiritually ready for it and would use such technology for destructive purposes.<sup>27</sup>

According to the literature reviewed by Andrew Johnson,<sup>28</sup> on 20 February 1954 at Edwards (Muroc) Air Force Base, President Eisenhower and others met with two white-haired Nordics. They had pale blue eyes and colourless lips. These ETs arrived in a bi-convex saucer that stood on tripod landing gear on the landing strip. The Eisenhower administration rejected the Nordics' offer of spiritual rather than technological help and instead formed the above-mentioned agreement with the Greys.

## Greys broke the Treaty

William Cooper writes<sup>27</sup> that the Greys' contempt for the Treaty was obvious by 1955 when mutilated humans and animals were being found all over the United States. Further, it was suspected that the Greys were not returning all abductees.

## 2.7 Bob Lazar (1959 – )

According to Bob Lazar in an interview (1989)<sup>29</sup> he worked as a physicist at the S-4 facility (underground, inside the Papoose Mountains, near Area 51) for about six months as of early 1989, where he:

- Worked on back-engineering an ET spacecraft.
- Entered the ET craft and studied it.
- Witnessed test flights of ET craft which must have been retrofitted to accommodate human pilots.
- Learned that the ET crafts at S4 originated from a planet orbiting the Zeta Reticuli star system [home of Grey ETs].
- Saw autopsy photographs of an ET, including a chest cut open and a dissected organ that showed the different chambers. The ET looked like a typical Grey about 3.5 to 4 feet tall.
- Learned of an incident in 1979 that halted an information exchange programme between ETs and humans. ETs who were working with humans became hostile and killed a number of security personnel.

Bob Lazar stated the following in relation to the government and ETs:

- The government is only serving their own interests, not ours.
- Obviously ET craft exist.
- This implies that ETs must have factories and entire civilizations.

Although Bob Lazar denied properly seeing a live ET, in addition to seeing photographs of a dead short Grey, he said that during the course of his work at S-4 he:

- Read briefing documents that detailed alien involvement with Earth for over 10,000 years.
- The documents described Grey ETs from a planet orbiting the twin binary star system Zeta Reticuli.
- Through an open door at S-4 he saw two men in lab coats talking to “something small with long arms.”
- Senior employees at S-4 referred to the ETs there as “the kids.”<sup>30</sup>



### 3. New World Order and birds of a feather

In addition to Philip Schneider (discussed above) many other people have also observed that the brutal New World Order (NWO, Jew World Order, World Government) is a shared ET – Cabal agenda.<sup>31</sup> This is symbolized by the alien depicted at the top of the NWO pyramid.

It has also been observed<sup>8</sup> that particular ET species show a preference for associating with certain human groups: (a) the Nommo associated with the Dogon, (b) the Nordics associated with the Scandinavians, (c) the Anunnaki tried to help the Germans, and (d) the psychopathic Greys associate with the psychopathic Cabal. The commonalities between Greys and their human partners in crime are striking.

## 4. Summary of main points

1. At least three ET species (Greys, Reptilians, Nordics) have been seen on Earth in modern times.
2. Enlightened beings such as the Anunnaki ETs have enlightened religion (e.g. goddess Inanna, who symbolizes love, self-defence, and life) and enlightened friends (e.g. National Socialist Germany).
3. Unenlightened beings such as the Cabal have unenlightened religion (e.g. worship of Yahweh, aka Satan) and associates such as the psychopathic Grey ETs who also stream consciousness from the darkest realms of beyond.
4. Although Grey ET – Cabal collaboration in the US formally started in 1954 (Greada Treaty), in practice these parties seem to have been cooperating since at least 1953 (when large spaceships containing Greys visited Earth, Greys gave the US a 30-metre wide flying disc and the four Greys aboard went to Los Alamos National Laboratory).
5. The collaboration involved Greys giving scientific / technological support to the Cabal in return for freedom to harvest material from animals and humans.
6. Following the deal struck between Grey ETs and the Cabal, the incidence of animal and human mutilation killings soared.
7. A project to build flying disc simulators in which to train US Air Force pilots started in 1958.
8. The technical advisor on the flying disc simulator project was a short Grey ET who had worked with a US government agency since 1953 (presumably this Grey was one of the four Greys that brought a flying disc to the US in 1953).
9. The first flying disc simulator was put into operation in 1962 or 1963.
10. By early 1989 human pilots were conducting test flights of ET craft and work was underway to back-engineer a particular ET craft (it is possible that other ET craft were back-engineered before this date).
11. The reality of ET spacecraft logically indicates the existence of factories and highly advanced civilizations elsewhere in our universe.
12. The high-level Grey ET – Cabal collaboration suggests that (i) Grey ETs are involved in trying to establish the brutal New World Order and (ii) due to their superior intelligence, Grey ETs are at the top of the NWO pyramid.
13. In the words of the late Philip Schneider, the New World Order cannot be allowed to happen: This country is not going to a New World Order, Our patriot movement

will kick the parasites out!


14. Mr. Schneider's declaration expresses the love for our people, war against those who dare to attack us, and value of life that the Sumerian goddess Inanna stands for.
15. In paganism as it subsequently developed in Europe, the psychic forces operating through Mr. Schneider are those of Odin, the god of inspiration, shamanry and battle.

“He sliced their lips back to their teeth, and their ears back to their heads, and their tails to their backs — and wherever he could get a grip on their eyelids, he would cut these back to the bone. And the horses were mutilated thus, to the extent that no further use could be got from the horses.”

A reference to ET-type mutilation killings in the Mabinogion, a collection of Welsh tales based on old Celtic legends and mythology (referred to in a video by Richard D. Hall, 2016).<sup>1</sup>

## 1. Introduction

ET-type mutilation killings of animals and humans seem to have occurred since antiquity. In order for ETs to create humans and some of the animals (discussed in [Aliens 1](#)) harvesting and manipulation of biological material from creatures on Earth would have been necessary. Subsequently, sources such as the Mabinogion (quoted above) suggest that ET-type mutilation killings were known to occur at some level of frequency ever since. It seems likely that this frequency was low judging by the

infrequent mention of such events in our historical records.

## Early documented events

1606. An account in the official records of the Court of James I of England details unexplained livestock deaths in early 1606:

“... about the city of London and some of the shires adjoining. Whole slaughters of sheep have been made, in some places to number 100, in others less, where nothing is taken from the sheep but their tallow and some inward parts, the whole carcasses, and fleece remaining still behind. Of this sundry conjectures, but most agree that it tendeth towards some fireworks.”<sup>2</sup>

Late 19th and early 20th centuries. During this period many ET-type cattle mutilation killings occurred in England according to researcher Charles Fort.<sup>2</sup>

1966. Animal mutilation killing cases were reported in the Upper Ohio River Valley, around Gallipolis, Ohio, according to researcher John Keel.<sup>2</sup>

1967. In this year the mutilation killings became more widely known outside cattle-raising communities after a horse named Lady died of an ET-type mutilation near Alamosa, Colorado.<sup>2</sup>

## Increased frequency

Since the late 1960's the incidence of mutilation killings has surged,<sup>3</sup> especially since the 1970s.<sup>4</sup> Due to government cover-ups it is difficult to estimate how many mutilation killings have occurred since this phenomenon became much more common. It is especially difficult to estimate how many humans have been killed in this way since the 1960s. However, available information about ET-type mutilation killing of humans, including the speed and secrecy with which government agencies remove the bodies, suggests that the number of ET-type human mutilation victims in the present era could be horrifying. This is consistent with the large number of young people who go missing each year and are never seen alive again.

## Missing people

Although it seems that the remains of most mutilated animals are left at the attack site for the owner or nature to deal with, apparently the remains of most mutilated humans are either not left at the attack site or they are promptly removed by government agencies who will try to prevent the next of kin and the general public

from ever knowing the truth about the victim's disappearance (e.g. the findings of Tony Dodd<sup>5</sup>). Therefore, to some extent, the inexplicable disappearance of a loved one, especially if the person is young, could indicate a possible ET-type mutilation killing, particularly by the government as they seem to be doing most of the mutilation killings.

The incidence of human mutilation killings is potentially huge. Safe at Last<sup>6</sup> states that about eight million children are reported missing worldwide every year, teenagers are the most common age group for abduction, but over 99% of missing children return home alive. Even if only 0.5% of those missing children are never seen alive again, that is 40,000 young people who go permanently missing world-wide every year. Depending on how many of those young people we estimate to have been victims of regular kidnapping, sex trafficking and murder, that can still leave many hundreds or even thousands of young people who were potentially victims of ET-type mutilation murders every year.

We do know for certain that the mutilation killings of animals and humans is a global phenomenon and that many thousands of ET-type animal mutilation killings have been reported around the world, especially where animals are herded.<sup>7</sup>

## **Government killers**

It is shown below that the surge in mutilation killings is due to the government (more specifically, the Cabal in control of our societal levers) mutilating and killing animals (and to an unknown extent, humans) on an industrial scale.

## **2. The victims**

A wide range of domesticated and wild animals are targeted. Domesticated animals include cattle, horses, sheep, goats, pigs, dogs and cats. Wild land animals include buffalo, bison, elk, small deer, badgers, foxes, rabbits, ground hogs and hedgehogs. Wild sea mammals include dolphins and seals. Birds are also targeted as well as humans. There is also evidence to suggest that the mutilation killers focus on certain breeds of animal, e.g. certain breeds of cattle, horses and seals.<sup>8,9</sup>

Victims tend to be relatively young.<sup>7</sup>

## **3. Body parts targeted**

Injuries vary somewhat across species, within species and across time. For example,

in contrast to animals, many young human victims have had all their skin removed, a feature that was not seen in ET-type mutilation killings of young people before the government started mutilation killing. Similarly, the draining of animals and humans' blood seems to have started (or at least become routine) since the government started mutilation killing. Evidence of government-specific mutilation killing features are discussed below under Differences: ET vs government killings.

A common mutilation pattern in cattle and sheep: jaw strip (muscle and tissue are removed down to the bone usually on one side of the jaw), removal of one or both eyes and ears, excision of the tongue deep at its root, removal of internal and external genitalia, and removal of digestive and other soft internal organs. Injuries across mutilation victims more generally include: decapitation, bifurcation (cutting into two parts) of the torso and removal of all internal organs, brains removed through small portals bored through the skull, and — in the case of seals and dolphins — deep corkscrew lacerations running along the entire length of their bodies. To some extent, soft tissue removed from victims can be characterized as being associated with the digestive, reproductive, endocrine, cardiovascular, lymphatic and respiratory systems. Finally, mutilation victims are left with little or no blood in them and there is no blood anywhere in the vicinity of the body.<sup>7</sup>

## **Sudden impact injuries**

These injuries are due to victims being dropped from height after the mutilation killing or in some cases, without mutilation (as if the victim was not considered suitable for harvesting). Therefore in many cases victims are found with broken limbs, ribs, and other bones. This is associated with markedly depressed ground beneath a carcass and sometimes broken branches of trees through which the victim fell. Occasionally the carcasses of large wild animals are found in trees or entangled in high voltage power lines.<sup>7</sup>

# **4. The method**

## **Marked in advance**

These premeditated and highly efficient attacks involve marking victims in advance. Many cattle were found to have been marked with fluorescent paint on their backs and sides in advance of the mutilation killings. This would enable the killers to shine a UV light on herds at night in order to attack marked animals.<sup>9,10,11,12</sup>

Similarly, Richard D. Hall<sup>13</sup> refers to a case in Wales involving a man and a woman parked in a car in a remote location at night. After seeing a light in the sky (a silent

helicopter?) the car was covered in a white powder. The light disappeared and they promptly drove away. The history of such incidents suggests that if they had not been observant and left when they did, soon thereafter an ET-type craft would have arrived to mutilate / murder them.

There is also evidence to suggest that in some cases electronic devices are used to mark intended victims.<sup>14</sup>

## Surgical features

Laser-like. Flesh looks as if it could have been cut with a laser but injuries do not show carbon residue as would occur if the tissue was exposed to the heat of a normal laser.<sup>7</sup>

Small holes. Internal organs are removed through portal incisions which are uniformly smooth and bloodless, with serrated edges. Similarly, brains are sometimes removed through a small hole bored through the upper skull. For example, in one incident a farmer discovered four cows with holes drilled into their skulls and the brains removed.<sup>7</sup>

## Scientific explanation

From Andrew Johnson (2019):<sup>9</sup>

1. ETs informed Wilbert Smith (1910-1962, M.Sc. Electrical Engineering, ET researcher and contactee) about “**binding forces**,” a force to which materials are subject.
2. Although current physics does not acknowledge this type of force, under instruction from ETs Smith built a “**binding meter**” and successfully measured the binding forces of various materials.
3. Smith learned from ETs that **binding forces can be altered**.
4. Known examples of binding force alteration include the disintegration of **Thomas Mantell’s plane** (USA, 7 January 1948) when it entered the operational field of an ET spacecraft (this case is described in the appendix of [Aliens 2](#)), “**dustification**” of the **World Trade Center** by means of directed energy weapons on 9/11 (see the scientific analysis of Dr. Judy Wood in her book *Where Did The Towers Go?*) and findings of researcher John Hutchison.
5. In Wilbert Smith’s Ottawa Address (31 March 1958)<sup>15</sup> referred to by Andrew Johnson,<sup>9</sup> it is further explained that **by manipulating the three basic fields**, not only can **binding forces** of an object be reduced, but **temperature** can be increased, potentially to very high levels.

Also, perhaps by means of the above-mentioned ET technology, there are many cases (some of them featured in [Aliens 2](#)) of ET craft or ETs using a torch-like device to paralyse or immobilize people at a distance. An ET or human using such technology could control their victims as required for capture and harvesting.

In summary, this ET technology can potentially explain the methods by which victims are attacked: (a) capture / control with the immobilization tool, (b) surgery involving high heat but anomalies that are inconsistent with the effects of known human technology and (c) removing organs in a stream of material by suction via small holes after reducing the binding forces of targeted organs. Perhaps the removed organs regain their original shape thereafter when bindings forces are increased.

## Other features

Lack of blood, footprints or tracks at the scene, delayed decomposition, predator and scavenger avoidance of the carcass, and domesticated animals visibly agitated and fearful of mutilated carcasses.<sup>7,9,16,17</sup>

Also, no law enforcement agency has identified anyone responsible for carrying out any of these many thousands of mutilation killings.

## 5. The killers

Expert analysis of ET-type mutilation killings consistently rules out natural predators or humans using known technology — but not ETs, humans using ET technology or humans working with ETs. Prior to humans acquiring (as of the 1947 Roswell spacecraft crashes) and being in a position to use ET technology for ET-type mutilation killings, all ET-type mutilation killings would have been by ETs. Further, evidence presented in [Aliens 3](#) suggests that ETs (including reptilians) have continued to do some of the animal and human mutilation killings, independently of humans (no collaboration with humans).

Some authors (e.g. the literature review of Andrew Johnson, 2019<sup>9</sup>) suggest that most of the mutilation killings since the 1960s are done by humans (military personnel serving the Cabal) using ET technology.

Another view expressed on UFO websites is that a substantial amount of mutilation killings are perpetrated by Grey ETs in collaboration with humans. For example, in an online discussion of why our government and ETs mutilate cattle (2014), a reader comments, “Evil Greys and Cabal are together in this.”<sup>3</sup>

Evidence presented in [Aliens 2](#) and [Aliens 3](#) (in the US there were Grey ETs living in underground bases and collaborating with humans, humans operating ET-type craft, some mutilation killings by ETs who are not collaborating with humans) is consistent with all three views, i.e. some mutilation killings are done by ETs acting independently but most of these crimes are done by humans using ET technology or perhaps humans and Grey ETs working together, including Grey ETs flying some of the ET-type craft used in the mutilation killings.

Following is additional evidence concerning the ET vs human vs ET+human views.

## **Proof of ET technology and ETs**

UFOs are consistently seen operating in the places where mutilations occur.<sup>7,10,18,19</sup> and farmers near Shrewsbury witnessed sheep being “lasered” by unidentified light from UFOs.<sup>18</sup> In many mutilation cases ET-type aircraft were actually seen taking animals.<sup>10</sup>

Further, ETs themselves have been seen in relation to the mutilations. In France (1954) two small humanoid figures were seen walking toward their landed aircraft and thereafter three cows in nearby farms were found dead, with all their blood removed (this case is discussed in [Aliens 2](#)) and in Vancouver, Canada (1990) a resident saw a “little man” running in a field carrying a strange device similar to a torch.<sup>19</sup>

Physical evidence of ET-type craft at mutilation sites is similar / identical to that found at sites of known UFO landings and includes circular depressions in the ground, sometimes smaller triangular depressions suggesting landing gear, burn marks on the ground, large discoloured circular rings in the soil which defy normal vegetation growth for long periods of time<sup>7</sup> and high radiation readings around a carcass.<sup>10,20</sup>

## **Proof of human involvement**

### Human drugs in cattle

Ted Oliphant, police officer in Fyffe, Alabama, investigated over 35 cases of cattle mutilations. Between 1993 and 1997 he found non-veterinary drugs (Barbiturates, Anti-coagulants, Synthetic Amphetamines, Aluminum-Titanium-Oxygen-Silicon flakes, and Antimony) in bovine blood. These are pharmaceuticals used for humans. Consequently law enforcement agents who had thoroughly investigated cattle mutilation killings concluded that some kind of medical testing was going on.<sup>17</sup>

## Unmarked helicopters

Since the 1960s unmarked helicopters (sometimes referred to as black helicopters and military helicopters) are consistently seen operating in the places where mutilations occur. The helicopters are often seen at mutilation locations both immediately before and after mutilations.<sup>1,7,10,12,17,20</sup>

Observers often note that the helicopters are surprisingly quiet.<sup>21</sup> This is consistent with the virtual silence of the Eurocopter Blue Edge rotor blade system.<sup>12</sup>

## The military operate the helicopters

In 1976 a sheriff noticed that sightings of the black helicopters preceded mutilation killings of cattle by a day or two and that the helicopters were landing at the small Cache-Logan Community Airport. Late one evening, after seeing three unmarked and unusually quiet helicopters in the sky, the Sheriff's deputy and several others rushed to the Cache-Logan airport. They saw a small airplane on the runway alongside one of the three helicopters. A man wearing coveralls left a helicopter with a shiny suitcase and gave it to the airplane's pilot. The helicopter's door was left open and allowed the sheriff to see "Property of U.S. Army" inscribed on the door of the helicopter. The Sheriff warned the man who had carried the suitcase that police and ranchers in the area suspected the helicopters of involvement in the cattle deaths and would shoot the helicopters down in future. After this confrontation, the unmarked helicopters were not seen again in northern Utah and southern Idaho and cattle mutilations there ceased for about five years.<sup>10</sup>

Similarly, later in 1976, a National Sheriff's Association colleague in Texas reported that cattle mutilations in that area ceased soon after organized armed patrols began closely monitoring the unmarked helicopters.<sup>10</sup>

In 1993, on a tip-off, police officer Ted Oliphant went to a certain place in the evening and saw these helicopters where they landed to refuel (from two Chinook helicopters) in a field behind some trees. After refuelling, the helicopters were tracked to their home base, Fort Campbell, Kentucky. This event occurred in association with cattle mutilations in Sand Mountain, North East Alabama. On the basis of this evidence, Ted Oliphant suggested that many cases of cattle mutilation are actually our tax dollars at work.<sup>17</sup>

In the UK [date not given] after intelligence and military departments held secret meetings, resulting in a decision to have fighter jets on standby to pursue the unmarked black helicopters and force them to land, almost immediately sightings of

the helicopters ceased for some time.<sup>12</sup> The helicopters are unlikely to have stopped flying after this meeting if it was not the military themselves who were operating the helicopters.

The above-mentioned four incidents show that the unmarked helicopters are (a) operated by the military and (b) part of an enormous mutilation killing operation. In other words, the government has been harvesting body parts from animals and likely also humans.

The military operate the ET-type craft

Police officer Gabriel Valdez, who served in the New Mexico State Police, pursued the criminals behind animal mutilations so hard that they eventually ceased their criminal activity in areas where Valdez was active. As a result of Valdez' efforts, on 20 April 1979 at the Albuquerque Public Library at Albuquerque, New Mexico, the Federal Bureau of Investigation (FBI) held a conference (chaired by Senator Harrison Schmitt and attended by about 180 people) about the cattle mutilation problem. Thereafter official correspondence records that there were no further reports of cattle mutilations in Indian country since March 1979.<sup>11, 22, 23</sup>

It has also been noticed<sup>24</sup> that ET-type mutilation killings seem to respect county (police jurisdiction) lines, i.e. there are human perpetrators involved. As with the helicopter operators, the ET-type craft operators show awareness that indicates human criminals are involved in operating the ET-type craft.

Other proof of human perpetrators

One night Gabriel Valdez and others approached an ET-type craft that was hovering in a pasture. The craft's lights went out and it then flew low over their heads. It sounded like a small lawnmower motor, not the sound (e.g. whirring, buzzing) normally associated with an ET craft.<sup>9</sup>

In one cattle mutilation incident, a gas mask was found next to a dead animal.<sup>9</sup>

As ET-type craft are involved in mutilation killings, and government awareness of police and general public opposition to the killings resulted in a cessation of the killings, the implication is that the government / military is operating both the unmarked helicopters and many of the ET-type craft involved in the killings.

**ETs or humans on government ET-type mutilation craft?**

The discovery of a gas mask at a killing site and the man-made-sounding ET-type craft suggests that at least some of the government mutilation killings are conducted by its human employees. Considering the training of human pilots on flying disc simulators, secret human test flights of ET craft, back-engineering of ET craft, and the numerous sightings of the military's man-made ET-type craft (see [Aliens 2](#) and [Aliens 3](#) for details), it seems likely that (a) most if not all of the government mutilation killings since the 1980s were done by its human employees using ET technology, with (b) Grey ETs providing scientific and technological support at facilities such as those mentioned in the previous two posts.

As a firm date reference, an ET-type craft seen in Rendlesham Forest (UK) on 26 and 27 December 1980 is judged<sup>9,25</sup> to have been man-made. The craft was triangular (about 9 x 9 x 9 feet) and pyramid-like in shape. Presumably it would have been too small to contain a large animal (e.g. cow) for mutilation but perhaps it could have dealt with small animals.

In summary, it seems likely that most if not all government mutilation killings since the 1980s were done by humans but there could have been a period as of the late 1960s (when mutilation killings started to surge) until the 1980s, when the government used Grey ETs to do the mutilation killings, i.e. the government could have used Grey ETs to do mutilation killings on its behalf for a period of over ten years.

## 6. Why do ETs kill?

According to Philip J. Corso (1915 – 1998),<sup>26</sup> Lieutenant Colonel in the United States Army, the US Government was aware of ET-type cattle mutilations since the mid-1950s, especially in the area around Colorado. At that time it was thought that the ETs might be harvesting organs for scientific purposes (e.g. transplant into another species, or creation of a hybrid biological entity) or food (e.g. processing into a nutrient package).<sup>26</sup>

Science and to a lesser extent food are still named as reasons for the ET mutilation killings. For example, non-specific references are made to humans and some animals being part of an ongoing biogenetic experiment.<sup>10,27</sup> In more general terms, as I suggested in [Aliens 2](#), it seems reasonable to think of ETs' activities on Earth, including mutilation killings, as exploitation and management of Earth's resources for reasons that we can only speculate about at present. In contrast, there is plenty evidence to help explain why the government mutilates and kills.

## 7. Why does the government kill?

### 7.1 Research

As was noted above, Ted Oliphant found pharmaceutical evidence that indicated cattle were being used for medical testing. He elaborated by linking his findings to the nature of the mutilations:

- Every organ taken from affected livestock has to do with input, output and reproduction.
- Where entire jaws have been excised in large, oval excisions, the bone is exposed and is perfectly clean.
- The wounds have been cauterized and there is no presence of blood.
- The jaw is an important part because enzymes are produced there. Enzymes that can kill viruses and bacteria. It's an antibody factory.
- The digestive track also acts as a filter. It absorbs, collects and stores traces of any chemical or toxin introduced.
- The rectum is a similar filter as are ears. They store traces of toxins and chemicals like a library.
- As many diseases (like CJD and BSE ) can be inherited, the reproductive system may be a good place to look for clues on how it is passed to the next generation.<sup>17</sup>

Similarly, Richard D. Hall (2016)<sup>1</sup> suggests that soft tissue and blood is removed in order to sample environmental effects and Andrew Johnson (2019)<sup>9</sup> notes that (a) the common removal of lymph nodes from cattle is consistent with research on the effects of anthrax or similar being introduced into the cattle or the environment and (b) liver samples from a mutilated cow showed a very high level of potassium (potassium iodine is used to block radioactive iodine from entering the thyroid).

In other words, as Andrew Johnson points out, (a) in part, the military seems to have been using other peoples' animals (and perhaps humans) to research weapons, including biological weapons and (b) the human perpetrators of animal and human mutilation killings consider themselves above the law and beyond the realm of normal ability to investigate serious crimes.

### 7.2 Animals used to grow antibodies

Richard D. Hall<sup>1,14</sup> supports this explanation of Dr. Philip Duke, who has investigated many mutilation killings:

- The animals are used to incubate certain antibodies for which the perpetrators have a future use.
- The killer targets an animal to be used as an incubator and then injects it with an agent (e.g. a virus) that causes the victim to grow antibodies against the agent.
- A certain period of time (weeks or months) is allowed to pass in order for the antibodies to become resident throughout the victim's blood and internal organs.
- The killer then returns to harvest the antibodies in a mutilation killing.
- Dr. Duke believes that in at least some cases HIV is injected into the victim for the purpose of growing HIV antibodies.

Richard D. Hall gives an example<sup>1</sup> of how horses have been used in this way to grow antibodies for injection into humans to prevent their bodies from rejecting transplanted organs. Rejection is a major cause of transplant failure and antibody specific to select immune components is occasionally used to treat severe acute rejection.<sup>28</sup> In such cases the organ recipient is infused with anti-lymphocyte globulin (ALG) animal- antibodies against human T cells.<sup>29</sup>

More recently the organ recipient can undergo genetic modification to deactivate genes that would otherwise cause the body to reject transplants.<sup>28</sup> Further, genetic engineering is now used to create transgenic animal systems that express human antibodies. Mice, rats, rabbits, chickens and cows have been modified to express human antibodies and therapeutic molecules derived from antibodies have become a dominant class of drugs.<sup>30</sup>

Considering the well-established facts of (a) the Cabal's criminality (discussed below in the sections Organ transplantation and Judaism) and (b) the Cabal's control of governments (e.g. see academic publications on the Occidental Observer, site of Prof. Kevin MacDonald), including the military (and their operation of ET-type craft for mutilation killings), it is necessary to consider the possibility that some of the Cabal's human mutilation killings have been for the purposes of regenerative medicine and organ transplantation.


## 7.3 Regenerative medicine and young blood

Regenerative medicine aims to replace, engineer or regenerate human or animal cells, tissues or organs to restore or establish normal function.<sup>31</sup> In particular, wealthy old people use the blood of young people for rejuvenation. People have long been aware of the potential for rejuvenating old people with the blood of young people. In 1492 three young boys were used to provide a blood transfusion for Pope Innocent VIII<sup>32</sup> and the novel *Dracula* (1897) by Bram Stoker features a vampire named Dracula who drinks his victims' blood to restore his youth.<sup>33</sup> The real origin of Count Dracula is in George du Maurier's 1895 novel *Trilby*, wherein the villain of *Trilby*, Svengali, is an Ashkenazi Jew. Bram Stoker was aware of Jew evil and intensely anti-Jew.<sup>34</sup>

There is evidence from animal studies to suggest that infusion of young blood into older people can temporarily reverse ageing in the older people, e.g. reverse age-related cognitive decline and revitalize cartilage, muscle (including heart) and liver.<sup>32,35</sup> Blood plasma contains proteins, enzymes and other antibodies to control disease and ageing and a growing number of clinics offer plasma from young donors to older people who can afford the fees.<sup>32</sup> Several companies offer young blood transfusions from 18-25 year old donors and charge from \$8,000.00 to \$150,000.00 for the treatment.<sup>35</sup>

Regardless of the ethics (e.g. exploiting poor donors) the market for young blood has expanded<sup>36</sup> and a growing number of start-up companies are intent on capturing some of the money available in this industry.<sup>37</sup> As a reader commented under the article *Can Blood from Young People Slow Ageing?*<sup>37</sup> in relation to the apparently

unlimited supply of young blood, “Shouldn’t law enforcement be looking into this?”



## 7.4 Jews and the illegal trade in body parts

There is a global shortage of organs available for transplantation and illegal organ trafficking is widespread.<sup>39</sup> Organ trafficking includes illegal organ harvesting from a living or dead individual and the illegal sale and transplantation of human organs. It is part of a broader market that includes tissues, cells, or other human body parts or products, referred to by some as the “red market.”<sup>40</sup> The most common transplant needs are for kidneys, followed by liver, heart, lung, and pancreas.<sup>40</sup> Other commonly required parts include corneas, intestines and bone marrow.<sup>41</sup> Organs are sold to anyone who wants organs and can pay for them. Skin, heart valves, bones, and corneas are sold for transplants, solid organs such as brains, hearts and livers are sometimes sold for research, presentations, or drills for medical students and surgeons.<sup>42</sup>

Instead of waiting years to legally acquire body parts, many people buy body parts from the criminal market. Although it is a criminal offence to traffic body parts or perform transplants from any source not legally affiliated with a hospital or other medical facility, this does not deter either side of these transactions. On the contrary, illegal organ harvesting is a booming, global and extremely lucrative business in which people are treated as nothing more than disposable products to be exploited for financial gain.<sup>41,43</sup>

Organs for the illegal trade may be obtained from:

- Deceased persons who did not consent to the use of their organs.
- Individuals who were killed for their organs. In some cases, criminal organizations have kidnapped and murdered people, especially children and teens, to harvest their organs for profit.<sup>39</sup> There are also many cases of suspicious deaths in which the victim had their organs removed.<sup>41</sup>
- Living persons who did not consent to the use or harvesting of their organs or were coerced, including by threat of force; were offered payment to take advantage of economic distress; or who consented to sell an organ but were misled about the nature of the medical procedure and recovery.<sup>40</sup>

Professor Nancy Scheper-Hughes of UC Berkeley stated: Israel is at the top of this criminal industry with worldwide tentacles. Israel has brokers everywhere, bank accounts everywhere, recruiters, translators, and travel agents who set up the visas.<sup>42</sup>

## **Examples of jewish criminality in this industry**

- In the 1990s, forensic specialists in Israel harvested skin, corneas, heart valves and bones from the bodies of Israeli soldiers, Israeli citizens, Palestinians and foreign workers, without permission from relatives.<sup>44</sup>
- Israel's very first heart transplant used a heart removed from a living patient (Avraham Sadegat) without consent or consulting his family. Indications that the removal of Sadegat's heart was the actual cause of death went unaddressed.<sup>45</sup>
- A Knesset member said that he "had received credible evidence proving that Israeli doctors at the forensic institute of Abu Kabir extracted such vital organs as the heart, kidneys and liver from the bodies of Palestinian youth and children killed by the Israeli army in Gaza and the West Bank."<sup>45</sup>
- The Forward reported: "In 2001, an Israeli Health Ministry investigation found that Prof. Yehuda Hiss had been involved for years in taking body parts, such as legs, ovaries and testicles, without family permission during autopsies, and selling them to medical schools for use in research and training. . . . Hiss was never charged with any crime . . . ." <sup>45</sup>
- The Economist reported: "Donors were recruited in Brazil, Israel and Romania with offers of \$5,000-20,000 to visit Durban [South Africa] and forfeit a kidney. The 109 recipients, mainly Israelis, each paid up to \$120,000 for a "transplant holiday"; they pretended they were relatives of the donors and that no cash changed hands." The trafficking was organized by a retired Israeli police officer.<sup>45</sup>
- The IPS reported:
  - “. . . trafficking can only take place on a major scale if there is a major source of financing, such as the Israeli health system.”
  - “. . . the resources provided by the Israeli health system “were a determining factor” that allowed the network to function.”

“... international trafficking of human organs ... [was] promoted by Zacki Shapira, former director of a hospital in Tel Aviv.”<sup>45</sup>

- An Israeli newspaper, the Jerusalem Post, reported: Ten members of an Israeli organ smuggling ring targeting Ukrainians were arrested. “Professor Zaki Shapira, one of Israel’s leading transplant surgeons, was arrested in Turkey ... on suspicion of involvement in an organ trafficking ring.” Apparently “the transplants were arranged in Turkey and took place at private hospitals in Istanbul.”<sup>45</sup>
- Levy Izhak Rosenbaum, a Jew from Brooklyn, was arrested by federal officials in a massive corruption that involved mayors, government officials and rabbis. “His business was to entice vulnerable people to give up a kidney for \$10,000 which he would turn around and sell for \$160,000.”<sup>45</sup> Rosenbaum pleaded guilty.<sup>43</sup>
- Dagens Nyheter reported:  
“Half of the kidneys transplanted to Israelis since the beginning of the 2000s have been bought illegally from Turkey, Eastern Europe or Latin America. Israeli health authorities have full knowledge of this business but do nothing to stop it.

“... Israel is the only western country with a medical profession that doesn’t condemn the illegal organ trade.” “The country takes no legal measures against doctors participating in the illegal business – on the contrary, chief medical officers of Israel’s big hospitals are involved in most of the illegal transplants.”<sup>41,43,45</sup>

## 8. Differences: ET vs government killings

My impression after studying many mutilation killing reports (articles, videos, photographs) is that the mutilations done by ETs are different to those done by the government. There are possibly also differences between the mutilations done by different ET groups (most likely sub-species of Greys and Reptilians according to information in Aliens 3), depending on their objectives. However these seem to be distinguishing characteristics of government mutilation killings:

### Removal of more organs from young victims

If a human victim is young (adolescence or early adulthood) it seems that more of the organs are missing, including all the skin. The total removal of young humans’ skin seems to have occurred in the Dalby Forest (UK, 1980s or early 1990s) cases reported by Tony Dodd<sup>5</sup> and it occurred in the Brecon Beacons case (UK, 20 Aug 1990) reported by Richard D. Hall.<sup>13</sup> On this point, skin grafts are done for a variety of reasons (e.g. infection, burns, ulcers, breast reconstruction) and the skin of unrelated people (allograft) can be grafted onto patients.<sup>38</sup> It is notable that since the Cabal started doing ET-type mutilation killings, at least one young female victim was found with her breasts cut off and missing.<sup>13</sup>

This is in contrast to the first documented incident of human mutilation killing that (a) involved autopsy and (b) unequivocally met the criteria for ET-type mutilation killing. In that case nine young Russian hikers were killed on 1 and 2 February 1959 (before the government started mutilation killing). Two of the bodies were missing eyes, one was missing the tongue and one was missing the eyebrows. There was no extensive skin removal and no blood removal reported. See the appendix for more information on this case.

## **Blood removal**

In contrast to the above-mentioned Russian case of no human blood removal and the early documented cases (e.g. the above-mentioned unexplained livestock deaths in 1606) that do not mention blood removal, blood removal is a typical feature of animal and human mutilations since the government started doing these crimes.

## **Respect for the bodies of dead humans**

As in many ET-type mutilation killings, the bodies of the above-mentioned young Russians showed sudden impact injuries, i.e. the ETs simply dumped the bodies from a height when they had finished with them, as they would do with animals. Although evidence indicates that the government also dumps animals from a height after harvesting, I am not aware of any evidence to suggest that the government has dumped human bodies from a height. On the contrary, human remains (e.g. the bodies of a young man and woman in the Brecon Beacons case discussed by Richard D. Hall<sup>13</sup>) seemed to have been placed carefully on the ground. This distinction between the treatment of animals vs humans is consistent with human killers showing at least some respect for their own kind, especially as the killers in the ET-type craft were likely not jews.

## **Murder disguised as mutilation killing?**

The ET-type mutilation killing of a 36 year-old professor of Agroecology in Brazil on 27 June 2019 has features that suggest the primary motive could have been murder. Apparently neighbours saw two men leaving the professor's home and driving off in his car around the time he went missing. The professor was known to be an assertive person and his work in ecology could have brought him into conflict with the interests of big money. The ET-style mutilation killing could have been a way of humans murdering him while feeling safe in the knowledge that no-one has ever been found guilty of an ET-type mutilation killing, animal or human. For those with access to the required technology, ET-type mutilation killing could be a preferred assassination method in some cases. See the appendix for more information on this case.



## 9. Judaism

### 9.1 The Talmud

Due to appalling ignorance, many people wrongly believe that the Old Testament (the Torah) is the supreme book of Judaism. In fact the Talmud is Judaism's holiest book (actually a collection of books). This is indicated in the Talmud itself, Erubin 21b (Soncino edition): "My son, be more careful in the observance of the words of the Scribes than in the words of the Torah (Old Testament)."<sup>46</sup>

Rabbi Joseph D. Soloveitchik is one of the most influential rabbis of the 20th century, the "unchallenged leader" of Orthodox Judaism and the top international authority on halakha (jewish religious law). He instructed and ordained more than 2,000 rabbis. In the NY Times on 10 April 1993, p. 38, religion reporter Ari Goldman described the rabbi's authority on the basis of his mastery of the Talmud. Goldman does not refer to Soloveitchik's knowledge of the Bible as the basis for him being a world authority on jewish law. The rabbi's credentials are all based on his mastery of the Talmud.<sup>46</sup>

Similarly, in Britain's Jewish Chronicle of 26 March 1993 it is stated that in religious school (yeshiva), jews are "devoted to the Talmud to the exclusion of everything else."<sup>46</sup>

In 1994, rabbi Tzvi Marx, director of Applied Education at the Shalom Hartman Institute in Jerusalem, said that jews have issued two sets of the Talmud: the authentic Talmud with which they instruct their own youth and "censured and amended" versions which they disseminate to the gullible goyim (non-jews).<sup>46</sup>

The Talmud contains all the Jewish laws for their relationships with each other, their relationships with gentiles, and it lays down the line for the destruction of the gentile peoples of the world, taking their wealth, and enslaving them. Threaded throughout the Talmud is the creed that makes the Jew such a dangerous parasite to every society he bores into. In the Talmud, gentiles and in particular White gentiles are referred to as goy. This is their derogatory term for the word cattle, or beast, and is sometimes spelt goyim. From early childhood Jews are taught that a gentile is a beast, to be treated as they would treat cattle. Interwoven throughout the Talmud is the idea of hostility and hatred toward the goyim. It is a detailed programme for binding the Jews together under a code of laws and a long-term programme for the destruction of the White race. The final aim is the complete destruction of gentiles and domination of the gentile world of which the White race is their most hated enemy. The Talmud came first and it is the supreme Jewish master plan overshadowing all other Jewish books. According to the Talmud, wherever possible, a Jew should kill the goyim and do so without mercy.<sup>47</sup> The Talmud is a statement of Jewish supremacism, hatred for non-Jews, and psychopathic treatment of non-Jews.

Some examples from this utterly disgusting Jewish “holy” book:

1. Minor Tractates. Soferim 15, Rule 10. Rabbi Simon ben Yohai: Tob shebe goyyim harog (Even the best of the **Gentiles should all be killed**).
2. Sanhedrin 57a. **When a Jew murders a gentile there will be no death penalty.**
3. Sanhedrin 58b. If a gentile hits a Jew **he must be killed.**
4. Sanhedrin 58b. **Hitting a Jew is the same as hitting God.**
5. Sanhedrin 54b. **A Jew may have sex with a child** as long as the child is less than nine years old.
6. Gad Shas 2:2. **A Jew may violate** but not marry **a non-Jew girl.**
7. Kethuboth 11b. When a grown-up man has **intercourse with a little girl it is nothing.**
8. Baba Mezia 114b. **Gentiles are not humans**, they are beasts.
9. Yebamoth 98a. All **gentile children are animals.**
10. Abodah Zarah 36b. **Gentile girls are in a state of** niddah (**filth**) from birth.
11. Tospoth Jebamoth 84b. If you eat with a gentile it is the **same as eating with a dog.**
12. Abodah Zarah 22a-22b. **Gentiles prefer sex with cows.**
13. Baba Kamma 113a. **Jews may use lies** to circumvent a gentile.
14. Sanhedrin 57a. **A Jew need not pay a gentile** the wages owed him for work.
15. Sanhedrin 57a. **What a Jew steals from a gentile he may keep.**
16. Moed Kattan 17a. If a Jew is tempted **to do evil** he should **go to a city where he is not known** and do the evil there.

## 9.2 The rabbis

1. **Rabbi Shimon bar Yochai:** He advocated the extermination of non-jews. Annually Israelis undertake a national pilgrimage to the grave of this rabbi to honour him. (Jewish Press, 9 June 1989, p. 56B)
2. **Rabbi Reichorn** (1859): “Wars are the jews’ harvest, for with them we wipe out the Christians and get control of their gold. We have already killed 100 million of them, and the end is not yet.”  
(Schonfield, Hugh J., 1936. The History of Jewish Christianity)
3. **Rabbi Kahane:** Arabs are “dogs.” A disciple of rabbi Kahane, Israeli army officer Baruch Goldstein, massacred 40 Palestinian civilians, including children, while they knelt in prayer in a mosque. University of Jerusalem Prof. Ehud Sprinzak said that Kahane and Goldstein “believe it’s God’s will that they commit violence against ‘goyim’ (a Hebrew term for non-jews).” (NY Daily News, 26 Feb 1994, p. 5).<sup>46</sup>
4. **Rabbi Chanina:** “He who strikes an Israelite acts as if he slaps the face of God’s Divine Majesty.”<sup>47</sup>
5. **Rabbi Yaacov Perrin:** “One million Arabs are not worth a jewish fingernail.” (NY Daily News, Feb. 28, 1994, p.6).<sup>46</sup>
6. **Rabbi Manis Friedman:** “I don’t believe in western morality, i.e. don’t kill civilians or children, don’t destroy holy sites, don’t fight during holiday seasons, don’t bomb cemeteries, don’t shoot until they shoot first because it is immoral. The only way to fight a moral war is the jewish way: Destroy their holy sites. Kill men, women and children (and cattle).” (Ask The Rabbi, Moment Magazine, May/June 2009).<sup>48</sup>
7. **Rabbi Yitzchak Ginsburgh:** “We have to recognize that jewish blood and the blood of a goy are not the same thing.” (NY Times, 6 June 1989, p.5).
8. **Rabbi Yitzchak Ginsburgh:** “If a jew needs a kidney, is it allowed, in order to save his life, to take the kidney from a goy (non-jew) passing by, even if he is not guilty of anything? In my opinion, Torah allows it. The life of a jew is priceless.”
9. **Rabbi Yitzchak Ginsburgh:** “. . . If a jew needs a liver, can you take the liver of an innocent goy (non-jew) passing by to save him? The Torah would probably permit that. Jewish life has an infinite value. There is something infinitely more holy and unique about jewish life than non-jewish life.” (Chabad-Lubavitch rabbi Yitzhak Ginsburgh in “Jewish Week,” the largest jewish publication in the United States, 26 April 1996)
10. **Rabbi Ovadia Yosef** (head of Shas Council of Torah Sages): “Goyim were born only to serve us. Without that, they have no place in the world – only to serve the People of Israel. Why are gentiles needed? They will work, they will plough, they will reap. We will sit like an effendi [a title of nobility meaning a Lord or Master] and eat. That is why gentiles were created.” (during a sermon delivered October

2010 in Jerusalem)

11. **Rabbi Menachem Mendel Schneerson:** The body of a jewish person is of a totally different quality from the body of [members] of all nations of the world. . . . Two contrary types of soul exist, a non-jewish soul comes from three satanic spheres, while the jewish soul stems from holiness. . . . The body of a jewish embryo is on a higher level than is the body of a non-jew. . . . A jew was not created as a means for some [other] purpose; he himself is the purpose, since the substance of all [divine] emanations was created only to serve the jews. . . . The entire creation [of a non-jew] exists only for the sake of the jews. (Rabbi Menachem Mendel Schneerson, Israel Shahak and Norton Mezvinsky, *Jewish Fundamentalism in Israel*; Pluto Press, 1999)
12. **Rabbi Shneur Zalman** (esteemed founder of Chabad-Lubavitch): The difference between jew and gentile is not merely religious or racial. The souls of jews and gentiles are completely different in kind. “Gentile souls are of completely different and inferior order. They are totally evil, with no redeeming qualities whatsoever . . . . Indeed they themselves are refuse. . . . All jews are innately good, all gentiles are innately evil.”

## 9.3 Jews' ritual mutilation murder of non-jews

According to the Christian website Watchman Willie Martin (1995):<sup>49</sup>

- Dr. Eric Bischoff, a famous German jewish scholar, found explicit authorization of jewish ritual murder in the Thikunne Zohar, Edition Berdiwetsch, 88b, a book of cabalistic ritual, as follows: “Furthermore, there is a commandment pertaining to the killing of strangers, who are like beasts. This killing has to be done in the lawful (jewish) method. Those who do not ascribe themselves to the jewish religious law must be offered up as sacrifices to the (jews) High God (Satan).”<sup>49</sup>
- This is consistent with the Talmud. It states that there are two kinds of blood pleasing to the lord [Satan]: that of Paschal holocaust [Easter sacrifice and the Feast of Purim], and that of circumcision — performed by ta rabbi (mohel).<sup>49</sup>
- Jews’ murder of Christian children usually occurs during the important feast-days of Purim, one month before Easter, and Passover, at Easter. Jewish law prescribes that the gentile victim at Purim may be an adult [it is usually an adult] but the victim at Passover must be a White child under seven years of age, who is bled white, crowned with thorns, tortured, beaten, stabbed, and finally stabbed in the side by a rabbi. The blood for Purim is dried and mixed into triangular cakes (Hamantash) for eating. The blood for Passover is mixed in either a liquid or powdered state into the Passover bread. Another festival at which ritual sacrifice has sometimes occurred is Chanukah (called Hanukkah today), in December.<sup>49</sup>

## Motives for the mutilation murders

- Hate is the principal motive in jews’ ritual mutilation murders.
- Superstitious traditions of atonement through blood-sacrifices. Some jews believed that jewry cannot be saved unless the blood of a Christian is ritually consumed every year.
- The vindictive ceremony reassures jews that they can silence their critics by murdering them. Consequently many critics of jews are slain in terrible circumstances.<sup>49</sup>

Jews have been caught many times in virtually every country in Europe committing ritual murder of gentiles for their occult blood rituals. Many jews who were caught confessed freely without any torture.<sup>50</sup> Following are examples of these ritual murders of Christians from long lists of such crimes published by Christians for Truth<sup>50</sup> and Willie Martin.<sup>49</sup> See the source articles for more information about these crimes, including criminal court-accepted proof and convictions, informal justice (killing the offenders in various ways), jewry’s invariable support for their ritual killers, and jews’ intense collective efforts to corrupt judicial processes, e.g. bribery, witness murder, and mass media support for offenders.

1144. In Norwich a twelve-year-old Christian boy was crucified and his side pierced at the Jewish Passover. His body was found in a sack hidden in a tree. (Close and Patent Rolls of the Realm, London, Winchester and Oxford)

1160. The Jews of Gloucester crucified a child. (Mons Germ. hist. Script 520)

1171. In Blois, France, at Passover, a child was crucified. His body was drained of blood and thrown into the river. (Monumenta Germaniae Historica, VI, 520; Magd. Cent. 12, c. 14 and 13, c. 14)

1179. In Pontoise, on 25 March, before Passover, Jews tortured, crucified and drained the blood of a boy named Richard before butchering him. Consequently the Jews were expelled from France. (Rob. of Turn., Rig. u. Guillel. Amor.)

1181. In Bury St. Edmunds, at Passover, Jews murdered a boy named Robert. (Acta sancti, III March Vol., 591)

1181. In Saragossa, Jews murdered a boy named Dominico. (Blanca Hispania illustrata, tom. III, p. 657)

1191. Jews of Braismé crucified a Christian who had accused them of robbery and murder, after they had previously dragged him through the town. Due to this King Philip Augustus, who had personally come to Braismé, burned eighty of them. (Rigordus, Hist. Gall.)

1220. In Weissenburg, Alsace, on 29 June, Jews murdered a boy named Heinrich. (Murer, Helvetia sancta.)

1225. In Munich a woman, enticed by Jewish gold, stole a small child from her neighbour. Jews drained the child's blood. Caught in her second attempt, the criminal was handed over to the courts. (Meichelbeck, Hist. Bavariae II. 94)

1235. Jews committed the same crime on 1 December in Erfurt. (Henri Desportes, Le mystère du sang, 66)

1236. In Hagenau, Alsace, three Christian boys from the region of Fulda were attacked by Jews in a mill during the night and killed for their blood. (Trithemius; Chronicle of Albert of Strassburg)

1238. In Fulda, Hesse-Nassau, Jews murdered five children for their blood. (Chron. Hirsau, and Magd. Cent., 13, c. 24)

1239. A general uprising in London because of a murder committed secretly by jews. (Matthew v. Paris, Grande Chron.)

1240. In Norwich jews circumcised a Christian child and kept him hidden in the ghetto in order to crucify him later. After a long search, his father found the child and reported the crime to Bishop Wilhelm of Rete. (Matthew v. Paris, op. cit. V. 39)

1244. In St. Benedict's churchyard, London, the corpse of a boy was found with cuts, scratches and Hebrew characters. He had been tortured, drained of his blood, and killed. The boy had been sold to jews by his parents. Distinguished jews left the city in secret. The Catholic Church venerated the Martyr under the name of St. Paul.

1247. In Valreas, France, just before Easter, jews murdered a two-year-old Christian girl. Her body was found in the town moat with wounds on her forehead, hands and feet. Jews confessed that they wanted her blood. Pope Innocent IV said that three of the Jews were executed without confessing. (Jewish Encyclopedia, 1903, Vol. III, p. 261)

1250. Jews of Saragossa adopted the horrible dogma that everyone who delivered a Christian child for sacrifice would be freed from all taxes and debts. In June 1250, Moses Albay-Huzet (also called Albajucetto) delivered seven-year-old Dominico del Val to the jews for crucifixion. (Johan. a Lent, Schedias, hist. de pseudomes, judæorum, p. 33)

1255. At Lincoln, England, on Peter and Paul's Day, jews murdered an eight-year-old boy named Hugh. He was stolen by local jews, hidden, and later crucified. Jews beat him with rods for so long that he almost lost all his blood. 18 jews were hanged for the crime. (Acta santa 6 July 494)

1257. So that they could commit their annual sacrifice, jews of London butchered a Christian child. (Cluvirius, epitome historiarum, p. 541. col I)

1260. Jews of Weissenburg killed a child. (Annal. Colmariens)

1261. In Pforzheim a seven-year-old girl was delivered to jews who laid her on a linen cloth and stabbed her limbs in order to soak the cloth with blood. Afterwards they threw her corpse into the river. (Thomas, Cantipratanus, de ratione Vitæ.)

1279. The most respectable jews of London crucified a Christian child on 2 April. (Florent de Worcester, Chron. 222)

1279. Jews crucified a Christian child at Northampton after unheard-of tortures. (Henri Desportes *Le mystere du sang*, 67)

1282. In Munich jews purchased a small boy and stabbed him all over his body. (Rader., *Bavar. sancta I. Bd. p. 315*)

1283. A child was sold by his nurse to jews of Mainz, who killed it. (Baroerus ad annum No. 61. *Annalen von Colmar*)

1286. In Munich jews killed two boys. The wooden synagogue was encircled with fire and 180 jews burnt to death. (Murer, *Helvetia sancta.*)

1286. In April, at Passover, in Oberwesel on the Rhine, jews murdered a 14-year-old boy named Werner. He was slowly tortured to death over a period of three days. He was hanged by the legs and bled white. (Act. sct. II. Bd. b. Apr. p. 697 bis 740.)

1287. At Passover jews in Bern crucified and horribly tortured a boy named Rudolf and finally slit his throat. (Hein, Murer, *Helvetia sancta.*)

1290. In Oxford, the Patent Roll 18 Edward I, m. 21, 21 June 1290, contains an order for the gaol delivery of a jew Isaac de Pulet, detained for the murder of a Christian boy. Only one month after this, King Edward issued his decree expelling the jews from the Kingdom. It is believed that this murder was the last straw for English tolerance of jewish criminality.

1292. In Colmar, jews killed a boy. (Ann. Colm., II, 30)

1293. In Krems, jews sacrificed a child. Two of the murderers were punished; the others saved themselves through the power of gold. (Monum. XI, 658)

1294. In Bern, jews murdered a child again. (Ann Colm., II, 32; Henri Desportes, *Le mystere du sang*, p. 70)

1302. In Reneken the same crime. (Ann. Colm. II, 32)

1303. In Weissensee, Thuringen, the young student Conrad, the son of a soldier, was killed at Easter. His muscles were cut to pieces and his veins were opened to drain all his blood.

1305. In Prague, around Easter, a Christian who worked for jews was nailed to a cross while naked, beaten with rods, and his face spat on. (Tentzel)

1320. In Puy a choirboy of the local church was sacrificed.

1321. In annecy a young priest was killed. The jews were expelled from the town by a decree of King Phillip V. (Denis de Saint-Mart.)

1331. At Uberlingen in present-day Baden, jews murdered a boy for his blood. (Joh. Vitoduran, Chronik.)

1338. Jews butchered a noble from Franconia in Munich. His brother massacred the criminals. (Henri Desport)

1345. In Munich jews opened the veins of a boy named Heinrich and stabbed him more than 60 times. (Rad. Bav. sct. II p. 333)

1347. In Messina a child was crucified on Good Friday. (Henri Desport)

1349. Jews wanted to attack and kill Christians assembled in their church at Rothenburg. A jew's maidservant exposed the jewish murder plot. The Christians stormed out of their church and killed all the jews. (Ziegler, Schauplatz p. 396 col. 1,2. Eisenmenger, entdecktes Judentum II, p. 219)

1350. A boy named Johannes, a student of the monastic school of St. Sigbert in Cologne, died after local jews stabbed him. (Acta sancta., aus den Kirchenakten v. Koln.)

1380. At Hagenbach in Swabia, several jews were surprised while butchering a Christian child. (Martin Crusius, Yearbook of Swabia, Part III, Book V)

1401. At Diessenhofen in Switzerland (near Schaffhausen), four-year-old Conrad Lory was murdered. It is said that his blood was sold to the jew Michael Vitelman for 3 florins. (Acta sancta.)

1407. Jews were expelled from Switzerland because of a similar crime in the same region. (ibid.)

1410. In Thuringia the jews were driven out because of ritual murder that was discovered. (Boll. II, April 838. Baronius 31)

1429. At Ravensburg in Wurttemberg, during Passover a Christian boy from Switzerland named Ludwig van Bruck was killed by three jews in an attack of torture and sexual violations. (Baron. 31, Acta sancta. III. Bd. des April p. 978)

1440. A Jewish doctor in Pavia beheaded a four-year-old child who was stolen and brought to him by a degenerate Christian. The crime became notorious when a dog jumped out of a window into the street with the child's head. The murderer escaped. (Alphonsus Spina, *de bello Judæorum* lib. III. confid. 7.)

1452. In Savona several Jews killed a two-year-old Christian child. They pierced his whole body and collected the blood in a vessel they used for circumcising their children. The Jews dripped small pieces of sliced fruit into the blood and enjoyed a meal of them. (Alphonsus Spina, *de bello Judæorum* lib. III, confid. 7.)

1453. In Breslau Jews stole a child, fattened him and put him in a barrel lined with nails, which they rolled back and forth in order to draw his blood. (Henri Desportes, *Le mystere du sang*, 75)

1454. On the estates of Louis of Almanza in Castile two Jews killed a Christian boy. They tore out his heart and burned it, then threw the ashes into wine which they drank with their co-religionists. Thereafter Jews were banished from Spain. (Alphonsus Spina, *de bello Judæorum*)

1462. In a birchwood at Rinn near Innsbruck, the boy Andreas Oxner was sold to Jews and sacrificed. (*Acta sancta.*, III. July Vol I. 472)

1468. At Sepulveda in Old Castile, Jews crucified a Christian woman on Good Friday upon the order of the Rabbi Solomon Pecho. (*Did. de Colm. Gesch. v. Seg.*)

1470. In Baden, Jews were convicted of murdering a Christian child. (Tho. Patr. Barbar.)

1475. In Trent on 23 March (Maundy Thursday) before Passover, Jews sacrificed a 29-month-old baby named Simon for Passover. A Jewish physician procured the infant for this purpose. The Jews stopped his mouth with an apron to prevent him crying out, made several incisions in his body, and collected his blood in a basin. Eventually they threw his body into a river.

1476. Jews in Regensburg murdered six children. A judge found the victims' remains in the underground vault of a Jew named Josfol, along with a blood-speckled stone bowl on a kind of altar. (Raderus *Bavaria sancta* Band III, 174)

1480. In Treviso Jews drained the blood of a boy named Sebastiano and murdered him in a crime similar to the one they committed in Trent. (H. Desportes, *Le mystere du sang* 80)

1480. In Motta, Venice, jews killed a child at Easter. (Acta sancta I. Bd d. April 3)

1485. In Vecenza jews killed a boy named Laurentius. (Pope Benedict XIV Bull. Beatus Andreas)

1490. In Guardia near Toledo, jews crucified a child. (Acta sancta I. Bd. d. April 3)

1494. In Tyrnau, Hungary, 12 jews seized a Christian boy, opened his veins, and collected his blood. They drank some of it and preserved the rest for their co-religionists. The arrested jews confessed that this was the fourth child they killed for their blood. (Banfin Fasti, ungar. br. III. Dec. 5)

1503. In Langendenzlingen a father handed his four-year-old child over to two jews from Waldkirchen in Baden for 10 florins under the condition that he would be returned alive after a small amount of blood was drained. However, they drained so much blood from the child that it died. (Acta sancta. II Bd. des April p. 839: Dr. Joh. Eck, Judebbuchlien)

1505. A crime, similar to the one in Langendenzlingen in 1503, was attempted at Budweis in Bohemia. (Henri Desportes, Le mystere du sang. 81)

1509. Several jews profaned the host bought from a sanctuary dealer and murdered several Christian children. (Cluverius, Epitome hist. etc. p. 579)

1509. Jews in Bosingen, Hungary, kidnapped the child of a wheelwright, dragged him to the cellar, tortured him horribly, opened all his veins and sucked out the blood with quills. Afterwards they threw his body in a hedge. The jews admitted their crime after repeated denials. (Ziegler Schonplatz p. 588, col. 1,2)

1510. In Berlin the jews Salomon, Jacob, Aaron, Levi Isaac, Rabbi Mosch and the butcher Jacob were accused of buying a three- or four-year-old Christian boy for 10 florins from a stranger, laying him on a table in a cellar, and puncturing him with needles in the large blood-rich veins until he was finally slaughtered by the butcher Jacob. The jews admitted to buying Christian children from strangers, stabbing them, draining their blood, and drinking the blood or preserving it with tomatoes, ginger, and honey. Forty-one of the accused jews were sentenced to death-by-burning after their confession. All the other jews were banished from the Mark of Brandenburg. (Richard Mun: The Jews in Berlin)

1520. Jews in Hungary repeated the crime of 1494 by draining the blood and murdering a Christian child in Tyrnau and Biring. (Acta sancta II. Bd. d. April p. 839)

1525. A ritual murder in Budapest caused a widespread anti-Semitic movement among the population. In this year the Jews were expelled from Hungary (Henry Desportes, *Le mystere du sang* 81)

1540. In Sappenheim, Bavaria, a four-year-old boy named Michael Pisenharter was kidnapped from his father before Easter and taken to Titting (North of Ingolstadt) where he suffered the most horrible tortures for three days, his veins were opened and his blood drained. The corpse showed signs of a crucifixion. The blood was found in Posingen. (Raderus, *Bavaria sancta*. III. Bd. 176f)

1547. In Rava, Poland, two Jews stole a tailor's boy named Michael and crucified him. (*Acta sancta* II. Bd. April p. 839)

1569. In Vitov, Poland, a two-year old boy named Johann was savagely murdered by Jacob, a Jew of Leipzig. (*Acta sancta ebenda*.)

1573. In Berlin a child was purchased from a beggar and tortured to death by a Jew. (Sartorius p. 53)

1574. In Punia, Latvia, the Jew Joachim Smierlowitz killed a seven-year-old girl named Elizabeth shortly before Passover. Her blood was mixed with flour and used to make Easter cakes. At about this time a Christian boy in Zglobice was stolen and taken to Tarnow, where another Christian boy was found in the hands of Jews under suspicious circumstances. Both were freed in time. (*Act. sancta* II. Bd. d. April p. 839)

1586. In a series of cases Christian children were snatched away from their parents and killed. By breaking down these crimes, Rupert traced them back to Jews. (Brouver *Trier'schen Ann.* v. J. 1856)

1592. In Wilna a seven-year-old Christian boy named Simon was horribly tortured to death by Jews. More than 170 wounds made by knives and scissors were found on his body, as well as numerous cuts under his finger- and toe-nails. (*Acta sancta* III. Bd. des Juli)

1595. In Costyn, Posen, a child was tortured to death by Jews. (*Acta sancta* 389)

1597. In Szydlow the blood of a child was used to consecrate a new synagogue. The child's eyelids, neck, veins, limbs, and sexual organs showed countless punctures. (*Acta sancta*, II Bd. des April)

1598. In Wodznick, in the province of Podolia, Poland, a four-year-old Roman

Catholic boy was stolen by two jews and butchered four days before Passover. He suffered the most horrible tortures in a ritual murder involving the most respected jews of the community. (Acta sancta, II Band des April 835)

1650. On 11 March in Kaaden, Steiermark, five-year-old Mathias Tillich was butchered by a jew. (Tentzel)

1655. In Tunguch, Lower Germany, jews murdered a Christian child for their Easter celebration. (Tentzel, monatl. Unterred. v. Juli 1693 p. 553)

1665. On 12 May in Vienna jews butchered a woman in the most dreadful way. The corpse was found in a pond in a sack weighted with stones. It was completely covered with wounds, decapitated and the legs were cut off below the knees. (H.A. von Ziegler, Tagl. Schaupl. p. 553)

1669. On 22 September, on the way from Metz to Boulay, near the village of Glatigny, the jew Raphael Levy stole a three-year-old boy from his mother and horribly butchered him. The body was found viciously mutilated. On 17 January 1670 Raphael Levy was burned alive for his crime. (Abrege du proces fait aux Juifs de Metz, ebd. 1670)

1675. At Miess in Bohemia a four-year-old Christian child was murdered by jews on 12 March. (Acta sancta II. Bd. des April)

1684. In the village of Grodno, Minsk government in Russia, the jew Schulka stole a six-year-old Christian boy named Gabriel. He carried Gabriel to Bialystock where, in the presence of other jews, the boy suffered ritual murder involving torture and draining of his blood. (Records of the magistrate at Zabłudvo)

1753. On Good Friday 20 April, in a village near Kiev, Russia, a three-year-old boy was stolen by jews, hidden in a tavern until the end of the Sabbath, and then monstrously sacrificed with the help of the rabbi Schmaja. His blood was poured into bottles. (Criminal Register of the City Court of Kiev)

1791. On 21 February the corpse of 13-year-old Andreas Takals, who lived with a jew named Abraham, was found outside a village near Tasnad, Siebenburgen. His blood was drained by severing the jugular vein. (Ger.-Akt i.d. Archiv. v. Zilah.)

1791. At the same time two blood murders were reported at Holleschau (Moravia) and at Woplawicz in the District of Duplin. (Tisza-Eslar, v.e. ungar. Abgeord.)

1791. During the reign of Sultan Selim III jews in Pera killed a young Greek by hanging him from a tree by his legs. (Henri Desportes)

1803. On 10 March the 72-year-old jew Hirsch from Sugenheim seized a two-year-old child between Ullstadt and Lengenfeld in Buchhof near Nuremberg. Several days later the jew denied having been in Buchhof at all on 10 March. The father of the child, who wanted to prove the contrary with witnesses, was rebuffed in court with threats and insults. On the 12th day the child was found dead, his tongue sliced and his mouth full of blood. (Friedr. Oertel, "Was glauben die Juden?" Bamberg, 1823)

1804. In Grafenberg near Nuremberg a two-year-old boy was stolen by the old jew Bausoh from Ermreuth. Soldiers hurried to prevent the crime after hearing the child's scream. (Dr. J. W. Chillany)

1810. Among the records of the Damascus trial is a letter from John Barker, ex-consul of Aleppo, which speaks of a Christian girl who suddenly disappeared from Aleppo. The jew Raphael of Ancona was charged with having drained all her blood and butchering her. (A. Laurent. Affaires de Syrie)

1812. In October on the island Corfu, three jews who had strangled a child were condemned to death. Some time later, the child of a Greek called Riga was stolen and killed by jews. (Achille Laurent, Affaires de Syrie)

1817. The Indictment of the murder in this year of a little girl named Marianna Adamoviez was quashed due to a lapse of time.

1823. On 22 April in Velisch, the Russian government of Vitebsk, a three-year-old boy was stolen, tortured to death and his blood drained. His body was found in a marsh one week later. There were ; puncture wounds all over the body and the skin was scarified. He had been rolled about in a barrel until his skin was scraped all over. There were also wounds of circumcision, his feet were bloody and a bandage had been tied around the legs. (Pavlikovsky, ebenda)

1824. In Beirut the interpreter Fatch-allah-Seyegh was murdered by his jewish landlord for ritual purposes.

1826. In Warsaw the body of a murdered five-year-old boy was found with more than a hundred wounds and his blood had been drained. The crime triggered insurrection in the whole of Warsaw. Jews protested their innocence without having been accused. (Pavlikovski, wie oben p. 282)

1827. In Vilna, Russia, the stabbed corpse of a boy named Ossib Petrovicz was found. According to the testimony of 16-year-old shepherd Zulovski, Ossib was kidnapped by jews. (Nach einer Mitteilung des gouvernement Vilna)

1829. In Turin the wife of merchant Antoine Gervalon was kidnapped. In the cellar she was prepared for sacrifice by two rabbis. With her last bit of strength she answered her husband who was going through the jewish quarter with soldiers, calling out her name. Thus she was freed. (Auszug aus einem Briefe des Barons von Kalte)

1831. The daughter of a corporal of the Guard in St. Petersburg was murdered. Four of five judges judges recognized it as a ritual blood murder. (Desportes)

1834. An old Gentile man in Tripoli was tied up by four or five jews and hanged from an orange tree by his toes. When the man was close to death, the jews cut his throat with a butcher knife and let the body hang until all the blood was collected in a bowl. (Henri Desportes, Le mystere du sang. 91)

1839. On the Island of Rhodes, an eight-year-old merchant's boy was delivering eggs to jews. He never returned. Jews delayed and finally suppressed the court case. (Henri Desportes, Le mystere du sang. 92)

1839. In Damascus the customs office discovered a jew carrying a bottle of blood. The jew offered 10,000 piastres to hush up the affair. (Prozess bei A. Laurent, op. cit. S. 301)

1840. In Damascus jews were preparing for the Purim feast to take place on 15 February. On 5 February jews attacked, gagged and bound the old Capuchin priest Father Thomas, put him in a secret room, and sent for the jewish barber Soliman. The priest was laid on a table with his head held over a copper bowl. The barber seized the priest by the beard, the jew Aaron Arari held his head, and his brother Davud Arari (the priest's friend) slit his throat. The blood was collected in the copper bowl and then poured into bottles.

Shortly afterwards the priest's servant Ibrahim Amara appeared in the jewish ghetto. The jewish Arari brothers, who were standing in front of the house, said to him: "Come on in, your Master is with us." Ibrahim Amara was then murdered in the same way as Father Thomas. Later pieces of the priest and his servant's body were found in the sewer.

All the jews involved in the murder were arrested and three of them (including

Soloman) confessed to the crime in detail. Several of the jews, including Mourad el Fathal, Mousa Abou-el-Afieh, Isaac Arari and Aaron Arari, stated that the blood was for use by a rabbi to prepare ceremonial bread. (Relation historique des Affaires de Syrie, 1840-1842)

1843. Jews murdered Christian children on Rhodes, Corfu and elsewhere. (Famont L'Egypte sous Mehemet Ali, Paris, 1843)

1875. In Zboro, county of Saros, Hungary, jews attacked 16-year-old servant girl Anna Zampa in the house of her master, Horowitz. The knife was already raised above her when a coachman accidentally intervened, thus saving her.

1877. In Szalaacs, country of Bihar, Hungary, jews murdered a six-year-old girl Theresia Szaabo and a nine-year-old boy Peter Szaabo. (M. Onody, ebenda)

1879. In Budapest, before the Purim feast, a young servant girl in the jewish Quarter was put to sleep with a drink. 24 hours after the feast she woke up so weak she could hardly walk. On her right forearm, her left thigh, and her body below the navel she had red circular wounds like spots of blood, with small openings in the centre. Blood had been drained from her. (M. Onody, ebenda)

1879. In Kutais, the Caucasus, four jewish image sellers killed a six-year-old girl. She was cut with a knife between her fingers and on her legs, a little above the calf. There was not one drop of blood in her veins. (Univers)

1881. In Kaschau, Hungary, the daughter of Josef Koczis disappeared. Two weeks later her body was found in a well completely bloodless. (M. Onody, Tisza-Eszlar)

1881. In Steinamanger the eight-year-old granddaughter of a coachman who worked for jews disappeared. (M. Onody, evenda)

1881. In Alexandria jews killed a Christian child named Evangelio Fornoraki. This resulted in riots against the jews. (Civita cattolica, von des. 1881)

1881. In the Galician town of Lutscha, Polish maid servant Franziska Muich worked for the jewish tavern-keeper Moses Ritter. She was raped and murdered by Moses and his wife. (Otto Glogau, der Kulturk. Heft. 128. 15. Febr. 1886)

1882. In Tisza-Eszlar, shortly before Passover, the 14-year-old Christian girl Esther Solymosi disappeared. She was last seen near the synagogue. The two sons of the temple-servant Josef Scharf, five-year-old Samuel and fourteen-year-old Moritz,

accused their father of murder. They stated that Esther was led into the Temple and butchered there. Her corpse was never found.

1882. In Galata, the ghetto of Constantinople, a child was enticed into a Jewish house. More than 20 people saw her go in. The following day her corpse was found in the Golden Horn. This caused great agitation among the Christian and Moslem population.

1882. A short time later another very similar case transpired in Galata. Serious, a distinguished lawyer of the Greek community, sent a petition to representatives of all the Christian European powers at Constantinople so that justice might be done. However the Jews bribed the Turkish police, who allowed certain documents in the case to disappear. Bribed doctors declared the mother of the kidnapped and murdered child to be mentally deranged.

1884. In January, in Sturz, West Prussia, the bloodless and dismembered body of 14-year-old Onophrius Cybulla was found under a bridge. A doctor stated that the dismemberments showed great expertise and dexterity with the knife. Suspicion immediately fell on various Jews and they were arrested. (Otto Glagau, *der Kulturki*, Heft 119. 15. Mai 1885)

1888. In July, in Breslau, Jew Max Bernstein, a 24-year-old Rabbinical candidate at the Talmudic college, murdered a seven-year-old boy named Severin Hacke. Bernstein had enticed Severin into his room. During the attack Bernstein withdrew blood from the boy's sex organ. Bernstein confessed: "The Bible and the Talmud teach that the gravest of sins can only be atoned for through innocent blood."

1891. In Xanten, Prussia, Jews murdered a five-year-old boy named Hegemann. In the evening of 29 June a maid found his body in the cow shed of the town councillor Koppers. His throat had been cut and the blood drained. The boy was already missed at 10:30 in the morning. He was seen by three witnesses being pulled into the house of Jewish butcher Buschoff. (Jewish Encyclopedia, Vol. I, p. 645)

1899. In Polna, Bohemia, on 26 March the single 19-year-old seamstress Agnes Kurza was slaughtered by the Jewish butcher Leopold Hilsner. On 1 April her almost bloodless half-naked body was found in a wood, the head nearly severed from the body, with no blood about the body. The Jew Leopold Hilsner confessed and implicated other Jews also involved in the murder. He described how they had chained the girl, cut her throat and collected her blood in a bucket. One of the helpers then took the blood by train for use in rituals. During further investigation it was found that Leopold Hilsner previously butchered another girl in the same way. His

previous victim was Marie Klima, slaughtered on 17 July 1898.

1900. In Konitz, West Prussia, on 11 March 1900 the 18-year-old college freshman Ernst Winter was ritually murdered. Two days later pieces of his dismembered body were fished out of the Monschsee. Almost five days later, on 15 April, his head was found by children playing in the bushes. The corpse was completely bloodless. The murder was carried out in the cellar of jewish butcher Moritz Levi, after the victim had been lured there by a young jewess. (Jewish Encyclopedia and B. Nachod. UJE)

1911. In Kiev, Russia, on 12 March jews murdered 13-year-old schoolboy Andrei Joutchinski. After eight days his corpse was found in a jewish brickyard. He had been gagged and wounded with a perforating instrument in the neck and temples. The cerebral vein and the left temporal and jugular arteries were severed, resulting in profuse haemorrhage. After he had lost about five glasses of blood, his body was pierced again with the same instrument, thus lacerating the lungs, liver, right kidney and heart, where the last wounds were inflicted. In all his body had 47 wounds, causing him acute suffering, the loss of practically all his blood, and finally death. It was proved that the murder occurred in the jewish brick factory, the religious centre of the Kiev jews, only jews had access to the premises, and that Andrei was murdered for his blood. (Ausführliche Darstellungen des Prozeßes enthalten 'Hammer' Nr. 271, 273, 274, 275; Oktober bis Dezember 1913)

1926. The bodily remains of the children Hans and Erika Fehse were found in a parcel on the public square in Breslau. They had been butchered. The corpses were bloodless. Their genitals were missing. The jewish butcher was believed to be the culprit. He disappeared without a trace.

1928. In Gladbeck, Westphalia, USA, college sophomore Helmut Daube was butchered on the night of 22-23 March 1928 at the time of Purim. In the morning his blood-drained corpse lay in front of his parents' home. His throat showed the ritual jewish cut, his hands were hacked to pieces, there were knife wounds to his abdomen, and his genitals were removed. (Der Sturmer)

1929. On 17 March in Manau, Lower Franconia, near Hofheim, a five-year-old boy named Karl Kessler was found in a wooded area butchered and bloodless, several days before Passover. A deep incision in the neck had severed his artery. His body also had smaller stab wounds and a light incision across the throat from ear to ear that indicated ritual slaughter as prescribed by the jewish law of human sacrifice. Suspiciously, the day after the murder a jewish butcher from Hofheim disappeared forever. (Der Sturmer)

1932. On 1 March 1932 in the United States jews ritually murdered the son of the famous Charles Lindbergh during the annual jewish celebration.

1932. In Paderborn on 18 March, Martha Kaspar was butchered and dismembered as Purim approached. The pieces of her corpse were found drained of blood. On 20 March her genitals were found in the middle of a road outside Paderborn. They had been expertly cut from her body. Subsequently pieces of her flesh were found scattered about Paderborn: in a small wood, in meadows, in willow stumps, in a pond, in a brook, in a sewer and in a manure pile. Her breasts, which had been sliced off, were found in the hay-loft and the jew had fed her intestines to pigs. Jew Moritz Meyer confessed to the crime and was convicted. (Der Sturmer)

1955. Five White children in Chicago, Illinois, were found ritually murdered. The three boys (11, 13, 14) and two girls (12, 15) were found nude, mutilated in various ways, and with their blood drained. The wounds of one boy contained traces of Matzah (unleavened flatbread, jewish cuisine, an integral element of the Passover festival). Injuries to the girls indicated a sadistic sexual aspect to the attack. Floor mat patterns embedded in the flesh of a boy showed that his body was transported in a Packard automobile, a luxury car popular among the wealthiest people of the time.<sup>51</sup>

## Continued ritual murder

According to Willie Martin (1995)<sup>49</sup> the ritual murders have continued. He states that jewish sects who keep the Passover still indulge in these bloody sacrifices of Christians and he explains how the blood is now obtained:

- There are now many jewish hospitals in the United States, owned and operated by jewish doctors and nurses. Parents who place their children in these jewish hospitals for minor ailments are stunned to be told a day or two later that the child suddenly died. In many such cases the child was removed to a synagogue and ritually murdered. Then the victim's bloodless body is turned over to the parents.
- Many of the children (White, Black, Mexican, Asian) who go missing every year are killed for their blood. Their drained blood is shipped to New York City, Chicago, Los Angeles, London, Paris, and especially Israel, where it is dried into a powder for making Hamantash (triangular cakes) and mixing with wine drunk in jewish religious rituals.

Note: The first known and most notorious modern serial killer ‘Jack the Ripper’ was a jewish immigrant from Poland, Aaron Kosminski.

## 9.4 Jews’ mutilation murders in 1917

Jews’ mutilation killings of non-jews are not limited to religious festivals. As one example of jews’ psychopathic hatred for non-jews, especially White people, consider the widespread Red Terror of the (jewish) Cheka(s) in 1917. Photographs taken at Kharkoff, in the presence of the Allied Missions, immediately after the Reds had abandoned the town, show:<sup>49</sup>

- Lips, nose, tongue, hands and scalp cut off
- Atrociously mutilated faces
- Numerous burns caused by a white hot sword blade, eyes burnt
- Foreheads branded with a red hot iron to show a five-pointed star
- Skin torn off the leg and hands with a metallic comb, or pulled off hands as one takes off a glove
- Female breasts slit and emptied, their genitals burnt with coal
- Genitals operated on and mutilated
- Sawed bones
- Shutting up victims naked in a barrel studded with nails and then rolling them about
- Shutting a victim in a chest containing decomposing corpses, telling the victim that he would be buried alive and then repeatedly burying the chest for half an hour and then re-opening it.

(S. P. Melgounov, p. 164-166; The Secret Powers Behind Revolution, by Vicomte Leon De Poncins, p. 151-153)<sup>49</sup>

## 9.5 Jews’ mutilation murders as of 2021

As was noted in Aliens 1, the mutilation murders have continued by means of the Covid “pandemic” and deadly “vaccinations.” In essence this looks like another case of mass poisoning by jews. This crime against humanity is much more complex and ambitious than simply poisoning drinking water but it is entirely consistent with

Talmudic instruction as referred to above.

## 9.6 Features of jews' ritual and other murders

- **Psychopathic.** In their murders jews show irrational hatred for the victim, extreme sadism and cruelty, perverse sexual motives, and total disregard for the sanctity of life. This behaviour is Talmudic instruction in action and psychopathic (previously termed sociopathic, currently called Antisocial Personality Disorder).
- **Ritual and government mutilation killing similarity.** Jews' ritual mutilation killings and some of their other murders are remarkably similar to the government's mutilation killings, e.g. extreme torture; draining of blood; puncture wounds; excision of body parts including breasts, genitals, tongue, heart; mutilating eyes; cutting muscles; beheading and dismembering. Concerning the blood-draining in jews' ritual mutilation killings and the government's mutilation killings, both are consistent with Kosher (Shechita) slaughter — a killing method that in practice causes prolonged suffering and nightmarish deaths.<sup>52</sup>

If instead of knives and traditional jewish butchering skills, jews had ET technology with which to pursue their Talmudic agenda, would they use this technology for sinister science, the human blood and organ transplant markets, and other criminal activity? Would the remains of animal and human mutilation killing victims look exactly as they do after the government ET-type mutilation killings?



## 9.7 Reasons for the 1,030 expulsions of jews

According to Lord Molyneaux's Empire (2018), The Complete List Of The 1030 Jewish Expulsions In Human History,<sup>53</sup> jews have been expelled from host societies on 1,030 occasions. To illustrate these practical consequences of jews' holiest book, the Talmud, following are examples of the reasons for jews being kicked out of civilized society.

### Ritual murder of gentiles

There are numerous occasions on which jews were expelled specifically for ritual murder of gentiles, typically children:

1189-1190 (Burry St. Edmunds, England), 1287 (Bacharach, Germany), 1290-1292 (Apulia and other towns, Italy), 1293-1294, (Berne, Switzerland), 1298 (Rindfleisch, Germany), 1321 (small town in France), 1336-1338 (Armleder, Germany), 1337 (Deggendorf, Germany), 1338 (Pulkau, Germany), 1347 (Messina, Italy), 1470 (Baden, Germany), 1475 (Trent, Italy), 1475 (Bamberg, Austria), 1478 (Mantua, Italy), 1478 (Reggio, Italy), 1479 (Milan, Italy), 1479 (Arena, Italy), 1479 (Portobuffole, Treviso, Italy), 1485 (Verona, Italy), 1492 (Aragon, Spain), 1492-1493 (Sicily, Italy), 1509 (Novi, Italy), 1529 (Posen, Germany), 1530 (Modena, Italy), 1533 (Silesia, Germany),

1541 (Tittingen, Germany), 1544 (Wurzburg, Germany), 1547 (Poland), 1553 (Asti, Italy), 1583 (Trieste, Italy), 1590 (Petrokov, Poland), 1712 (Poland), 1829 (Hamah, Syria), 1948-1949 (Yemen).

In addition to the above-mentioned cases, there are numerous other incidents in which jews were accused of ritual murder and suffered host retaliation, ranging from criminal prosecution to mass violence against jews.

## **Other murder of gentiles**

There are also many documented cases of jew expulsion for other actual or planned murder, e.g. jews killed gentile farmers (116 Oxyrhynchus, Egypt), a jewish doctor plotted the deaths of Christian patients (1430 Palermo, Italy), jews were accused of murdering the Constable of Castile (1473 Jaen, Spain), plotting a great massacre of Christians (602-610 Mesopotamia), cruelly putting Christians to death (614 Palestine), killing Christians (629 Jerusalem) and numerous cases of poisoning their hosts' drinking water (e.g. 1349 Salzburg, 1475 province of Tyrol).

## **Financial and business crime**

Financial and business crimes are often given as reasons for jew expulsion. Money lending, usury and other criminal banking practices seem to be the most common offence in this category. Other reasons for expulsion include cheating people out of money (139 BC Rome), money fraud (139 AD Rome, Italy), jewish merchant activity (1130-1135 Genoa, Italy), coin-clipping (1278 – small towns in England), medical/financial malpractice (1327 Iglasias, Italy), manipulating the price of corn (1349 Strasbourg, Germany), forging coins and smuggling good coins out of the region (an attempted expulsion, 1522 Nuremberg, Germany), jew silk-weavers expelled for illegality (1619 Kiev, Russia), criminality/racketeering (1777 Venice, Italy), jew silk-weavers expelled for criminality/organized crime (1780 Padua, Italy), for jewing the economy (1836 Bologna, Italy).

## **Siding with the enemy**

This too has often triggered expulsion, e.g. local jews caught "double-dealing" (66 Scythopolis, Greece), allying with Sicari from Palestine in revolt against Alexandrian prefect Tiberius Julius Lupus (72 Alexandria, Egypt), conspiring with Rome against Persia (255 Cappadocia), digging a tunnel from inside their synagogue under the city walls which the Persians used to breach the city of Telia, near Edessa (400-410 Telia, Byzantine Empire), plotting with an enemy to overthrow the King (558 or 561 Uzzes, Gaul), aiding influential Goths who had revolted (642 Visigoth Empire), siding with

jews of Septimania in revolt (673 Narbonne, France), allowing the invading Ottoman Turks to enter the city directly through the jewish quarter with the assistance of the jews (1453 Constantinople, Byzantine Empire), colluding with Turks in Hungary (attempted expulsion, 1530 Augsburg, Germany), aiding invading Turks (1541-1542 Bohemia, Germany), aiding the Turks at Lepanto (1571 Venice, Italy), siding with enemy after city is sacked during civil war (1639 Turin, Italy), treason (1683 Guadeloupe — French colony), helping Turks seige the city (1684 Buda, Hungary), “summoning the foreigner” (1799 Ancona, Italy), aiding Muslims during Italo-Turkish War (1911 Tuscany, Italy).

## **Subversion and revolution**

This is another common reason for jew expulsion, e.g. trying to physically take over a city screaming “jews take precedence over Greeks” and “the city is ours” (66, Caesarea), revolting against Rome (67 Ascalon, Syria; 67 Bethhoron, Syria; 67 Antioch, Egypt), revolting against the Byzantine Empire (527-565), initiating revolt in Septimania (672 Spain), leading an uprising (567-578 Caesarea, Byzantine Empire), organizing a conspiracy against the republic (1442 San Marino, Italy), influencing the Marannos to act against Spain’s interests (1486 Saragossa, Spain), subversive activity (1799 Bologna and Milan, Italy), subversive activity (1799 Modena, Italy), subversive activity (1799 Mantua, Italy), subversive activity (1822 Rubiera, Italy), revolutionary sympathies (1831 Leghorn, Italy), financing/aiding Mazzini’s Young Italy (1833 Leghorn, Italy), jewish rabbis expelled for revolutionary sympathies (1840 Piedmont, Italy), subversive activity (1842 Milan, Italy), aiding/financing revolution (e.g. 1848 Paris, France; Milan, Italy; Acqui, Italy; Venice, Italy; Berlin, Germany; Austria), subversive activity (1934 Piedmont, Italy), subversive activity (1937 Rome, Italy), spreading anti-Fascist propaganda (1940 Fiume, Italy),

## **Other crime**

Other criminal offences that triggered jew expulsion range from trying to destroy property of their host society (e.g. trying to set fire to the Greek amphitheatre, 66 Alexandria, Egypt; trying to set fire to a city, 71 Antioch, Egypt), extortion (1454 Genoa, Italy), bribery (e.g. after jews tried to bribe the Pope, 1455 Rome, and a Cardinal, 1527 Rome) and a kidnapping ring (1783 Ancona, Italy).

In addition to offences such as the above-mentioned that triggered expulsion, there are numerous other occasions where the offended host society massacred the jews in reaction to their crimes.

## **Summary of the jew problem**

Roman Historian Tacitus (AD 124, Histories, 5.15):

“. . . the other customs of the jews are base and abominable, and owe their persistence to their depravity. . . . the jews are extremely loyal toward one another, and always ready to show compassion, but toward every other people they feel only hate and enmity. . . . as a race [the jews are not a race, because they have mingled with the other races to the point that they are only a people, not a race], they are prone to lust . . . among themselves nothing is unlawful.”

Gilad Atzmon (2011, Israel Economy for Beginners):<sup>54</sup>

Soon, Russians, Americans, Africans, Europeans, all of humanity, will realize that we are all Palestinians and we all share one enemy.

## 10. Lunar factors in the killings

For the reasons given in Aliens 2, an association could be expected between the dates of genuine ET mutilation killings and lunar factors. However as it seems unlikely that the timing of government mutilation killings (the majority of the killings) would be influenced by considerations of energy availability in the natural environment (government ET-type craft could meet their energy requirements from their bases on Earth) we might see an association between the dates of government mutilation killings and lunar factors due to lunar influences on the physiology of victims.

Lunar cycles are among the more important natural factors that regulate health and reproduction of vertebrates<sup>55</sup> although light pollution is a global problem affecting both terrestrial and marine environments. Increased light pollution can help explain why early studies found circalunar rhythms in vertebrates while some of the more recent studies did not find such a relationship.<sup>56</sup> Nonetheless, there is evidence of lunar influences on the physiology of humans and other mammals, including other primates, badgers<sup>56</sup> and cattle. Spontaneous birth frequency of cows increased uniformly from new moon to full moon phase and decreased until the waning crescent phase.<sup>57</sup>

Human scientists involved in planning the mutilation killings would know about the lunar influence on physiology. To control for possible confounding factors (e.g. differences between breeds and species, and lunar influences) in their research, we could expect to see indications of the scientists holding such variables constant. As was noted above under The victims, certain types of animals (particularly breeds of cattle and horses; species of seal) are targeted. This is consistent with what would be expected in scientific research. Similarly, we could expect to see some consistency of

mutilation killings in relation to the moon. Apart from experimental control of unwanted influences, we might also see consistency on some factors for reasons of the desired product, e.g. quality, quantity and uniformity (of blood components and state of other body parts that vary across animals, humans and with lunar factors).

On the basis of the above, I analysed the dates of the 81 ET-type mutilation killings in relation to phases of the Moon and the Moon's perigee – apogee cycle using the method stated in Aliens 2.

## 2.1 Findings

ET-type mutilation killings: Lunar cycle and phase




Figure 1a. No. of mutilation killings per day across lunar cycle.  
Figure 1b. No. of mutilation killings per lunar phase.

Fewest mutilation killings occurred during First Quarter and most mutilation killings occurred during Last Quarter. The Chi<sup>2</sup> value for the difference between these two phases is 0.641. The p-value is .42334, i.e. the result is not significant at  $p < .05$ . This finding indicates that ET-type mutilation killings were not more likely to occur during Last Quarter than First Quarter.

Summary: ET-type mutilation killings by lunar phase

The ET-type mutilation killings were not significantly more likely to occur during any particular lunar phase.

ET- type mutilation killings: Perigee-apogee cycle and lunar phase




Figure 2a. No. of mutilation killings per day across perigee-apogee cycle.  
Figure 2b. No. of mutilation killings by lunar phase and closest point (perigee or apogee) in perigee-apogee cycle.

In Figure 2a light blue shading demarcates the cases that occurred closer to perigee from those that occurred closer to apogee. Notable feature of this chart: More cases occurred closer to perigee than closer to apogee. The Chi<sup>2</sup> value for the difference between these two groups is 7.716. The p-value is .00547. The difference is significant at  $p < .01$ .

In Figure 2b yellow shading highlights the biggest differences between certain lunar phase and perigee-apogee categories. The Chi<sup>2</sup> and p-values for the differences between these groups:

First Quarter with the Moon closer to Perigee vs First Quarter with the Moon closer to Apogee (Chi<sup>2</sup> value 2.882, p-value .08956). Although this difference is not significant at  $p < .05$ , it approaches significance at that level.

First Quarter with the Moon closer to Apogee vs Full Moon with the Moon closer to Perigee (Chi<sup>2</sup> value 4.263, p-value .03895). This difference is significant at  $p < .05$ .

Full Moon with the Moon closer to Perigee vs Full Moon with the Moon closer to

Apogee (Chi^2 value 2.333, p-value .12663). Although this difference is notable, it is not significant at  $p < .05$ .

Full Moon with the Moon closer to Apogee vs Last Quarter with the Moon closer to Perigee (Chi^2 value 1.8, p-value .17971). This difference is not significant at  $p < .05$ .

New Moon with the Moon closer to Perigee vs New Moon with the Moon closer to Apogee (Chi^2 value 2.333, p-value .12663). Although this difference is notable, it is not significant at  $p < .05$ .

### Summary: Perigee-apogee and lunar phase findings

The ET-type mutilation killings were significantly more likely to occur when the Moon was closer to Earth (closer to Perigee). Across all lunar phases most mutilation killings occurred when the moon was closer to Earth, with this difference approaching or reaching statistical significance in some comparisons.




Figure 3. ET craft sightings vs ET-type mutilation killings: No. of cases by lunar phase and closest point (perigee or apogee) in perigee-apogee cycle.

The above finding is opposite to that of ET spacecraft sightings (presented in Aliens 2) as is shown in Figure 3.

### ET craft sightings vs ET- type mutilation killings: Perigee-apogee cycle and lunar phase

There was a tendency for the ET craft to be seen when the Moon was further from

Earth (closer to Apogee), particularly during Last Quarter and New Moon. However, ET-type mutilation killings were more likely to occur when the Moon was closer to Earth (closer to Perigee).

## Interpretation of the lunar findings

The lunar findings support this view:

- ET craft operators have different considerations (e.g. energy, as was noted in Aliens 2) to those (e.g. scientific and harvested product considerations) of ET-type mutilation killing craft operators.
- Most ET-type mutilation killings were perpetrated by humans operating from bases on Earth. If this was not the case, the dates of ET craft sightings (analysed in Aliens 2) and ET-type mutilation killings would likely show a similar pattern in relation to the lunar factors. However the pattern is opposite — ET craft were more likely to be seen when the Moon was further from Earth and mutilation killings were more likely to occur when the Moon was closer to Earth.
- The lunar findings are consistent with human researchers holding perigee – apogee effects on targets’ physiology constant by killing / harvesting near perigee.
- The lunar findings are also consistent with humans killing / harvesting when the body parts are most suitable — assuming that the blood and other body parts are in a more suitable state at perigee rather than apogee.

# 11. Summary of main points

1. ET-type mutilation killings of animals and humans have surged since the late 1960's.
2. ET-type mutilation killings are a global problem that includes the murder of young people for their body parts.
3. The incidence of missing young people suggests that the incidence of ET-type murder of young people for their body parts could be high.
4. Repeated and reliable observation of humans involved in perpetrating ET-type mutilation killings and other evidence of human responsibility for these crimes indicates that since the late 1960s, most ET-type mutilation killings have been done by the government, i.e. the Cabal in control of our societal levers.
5. There seem to be significant differences between ET and Cabal mutilation killings on body parts targeted, the amount of body parts harvested, and treatment of human remains.
6. There is speculation about why ETs harvest animal and human body parts, including the possibilities of science (e.g. creating a hybrid biological entity) and food (nutrition for the ETs).

7. The Cabal mutilation killings are consistent with their publicly-declared transhumanist (“Great Reset,” New World Order, brutal world government by jews) ambitions, including mutilation killings for research, antibodies, and (in cases of human mutilation killings) regenerative medicine and young blood, and organ transplantation.
8. Jews have dominated the illegal trade in body parts in a global racket that included jewish doctors and rabbis.
9. Such criminality is promoted by jews’ holiest book, the Talmud, a statement of jewish supremacism, hatred for non-jews and psychopathic treatment of non-jews.
10. Talmudic criminality is strongly promoted by rabbis.
11. Reliably documented cases of jewish criminality include numerous instances of jews’ ritual mutilation murder of non-jews.
12. The primary motive for these ritual mutilation murders is hatred for non-jews, especially White people.
13. Similarly, jews’ psychopathic hatred for non-jews is evidenced in their sadistic torture and mutilation of numerous other White people whom they murdered.
14. A current example of Talmudic criminality is the terrible suffering of those who are now dead or dying of “vaccination” poisoning since 2021.
15. Due to their long history of outrageous crimes (e.g. poisoning, murder, financial crimes) against non-jews, jews have been expelled from civilized society on 1,030 occasions and counting.
16. In addition to the proof of Cabal perpetration of most mutilation killings since the 1960s, it is notable that the Cabal’s ET-type mutilation killings are similar to their ritual mutilation killings of Christians and some of their other murders, e.g. extreme torture; draining of blood; puncture wounds; excision of body parts including breasts, genitals, tongue, heart; mutilating eyes; cutting muscles; beheading and dismembering.
17. In some ways the remains of Cabal mutilation killing victims since the 1960s look as if instead of knives and traditional jewish butchering skills, the killers had ET technology and new objectives, e.g. sinister science and profit in the regenerative medicine and organ transplantation markets.
18. Known ET technology can help explain the methods by which victims are captured / controlled and operated on, including the removal of organs through small holes.
19. The analysis of ET-type mutilation killings in relation to lunar factors, and the comparison of these findings to those of ET craft sightings, adds weight to the conclusion that the Cabal has done most of the ET-type mutilation killings of animals and humans since the 1960s.

## 1. Points from Aliens 1 to 4

1. **1972**. The World Health Organization (WHO) published its intention to study ways in which the immune system could be weakened by a virus.
2. As of the late **1960s**, but especially as of the **1970s**, there was a surge in government ET-type mutilation killings for blood and other body parts.
3. There are notable differences between mutilation killings done by ETs vs those done by the government using ET technology.
4. Evidence indicates that reasons for the government harvesting body parts include research and harvesting antibodies, including **HIV antibodies** (findings of Dr. Duke).
5. **1981**. The first clinical reports of **HIV/AIDS**.
6. Evidence suggests that HIV could have been genetically engineered (Dr. Len Horowitz).
7. Prominent **Covid “vaccination”** pushers are connected to **HIV/AIDS** research.
8. The Covid “vaccination” **destroys immune function** (like HIV).
9. Apart from leading to serious illness and death, the loss of immune function **prevents rejection of “vaccine”** contents.
10. The **“vaccination”** is a key element of the **transhumanist agenda** (“Great Reset,” New World Order, brutal world government by jews).
11. The government’s ET-type **mutilation killings** are part of the **transhumanist agenda**.
12. The criminal history of jews in the illegal body parts market is consistent with some of the harvested human **body parts** being **sold for profit**, e.g. for organ transplantation.
13. The **Talmud and rabbis correctly state**: (a) **jews are fundamentally different** to non-jews in spirit, purpose and deed, (b) jews are a **mortal danger** to non-jews, and (c) this age-old conflict cannot be resolved until **light prevails over dark**.
14. These irreconcilable differences have **catastrophic practical consequences**, including jews’ well-documented relentless mutilation and other murders of non-jews driven by jews’ pathological hatred toward other people.
15. The psychopathic conduct by jewish “elites” involves endless lies, deception and

suffering of their victims, including those who died or are dying due to jews' **outrageous criminality** in their push for **world government** ("Great Reset," NWO, etc), i.e. rule over "vaccinated" sub-human survivors within a global electronic prison.

16. This monstrous crime against humanity is backfiring on the perpetrators — we see signs of **growing rage** against our self-appointed criminal rulers.
17. This catastrophic end to the Dark Age of Abrahamic evil contrasts with the enlightenment of the Anunnaki and other wise ETs who helped humanity in the pre-Abrahamic era (and to some extent thereafter, e.g. the Anunnaki help of National Socialist Germany).
18. Crucially, Anunnaki religion (and that of Martians, who might be Nordics, as was indicated in Aliens 3) is natural, i.e. pagan.
19. Natural religion involves heightened awareness of nature, our place within natural cycles, and respect for all expressions of the Divine — mountains, rivers, plants, animals, people, everything.
20. In contrast, 'prophetic' or 'revealed' religion such as the Abrahamic religions do not promote these virtues and instead predispose arrogance, ignorance and destruction of the Divine, including nature and people.
21. The catastrophe of transhumanism / New World Order / brutal World Government by self-appointed criminals is the logical outcome of jew / Christian mind-rot.

## 2. Birds of a feather

The principle of like associating with like was illustrated repeatedly in preceding Aliens posts:

1. The Anunnaki (created and civilized humans – Aliens 1; helped National Socialist Germany – Aliens 3), the Nommo (possibly another name for the Anunnaki, educated the Dogon tribe in Mali, West Africa – Aliens 3); and the Nordics warned Americans against the psychopathic Grey ETs (Aliens 3). These were cases of virtuous ETs associating with people whom they considered to be virtuous and worthy of their help.
2. Similarly, in Anunnaki religion the focus is on star systems associated with virtuous beings, including a goddess, and ignoring star systems that are home to evil-doers (they ignore the Zeta Reticuli and Alpha Draconis star systems, home to the anti-social Greys and Reptilians respectively – Aliens 3).
3. Conversely, the psychopathic Grey aliens have an affinity with the psychopathic Talmudic aliens, with whom they have collaborated to try enslave and rule the rest of us. This destructive criminal partnership has only flourished since much of humanity succumbed to the anti-life mind-rot of jewish religions, including Christianity – the antithesis of, and totally incompatible with, the pro-life natural religion (paganism) of the Anunnaki, the Nommo, and the Nordics (evidence presented in Aliens 3 suggests that the Nordics built the structures of natural religion on Mars).

Considering the above, it is unsurprising that pro-social ETs such as the Anunnaki have largely ignored humans since we abandoned their natural religion for the anti-life mind-rot of jewish religions.

## 2.1 Help vs no help from good ETs

As was noted in the post [From ET to Enlightened Time](#) in relation to Wilbert Smith (1910-1962, M.Sc. Electrical Engineering, ET researcher and contactee) ETs are interested in us and stand by ready, able and willing to help us. However they cannot help us until we are ready for their help. The above section implies that this means abandoning anti-life ways in favour of pro-life natural religion like theirs or its equivalent in the natural religion of our particular race (an evolved form of Odinism in the case of Europeans).



### 3. Personal responsibility

All reality is spiritual (primacy of consciousness, discussed in the post [Aspects of Mind](#)), behaviour reflects state of mind, and therefore the man-made catastrophes (ecological and human) of our times are outward expressions of our spiritual impoverishment. Blaming all our societal problems on jews is as naive as blaming all our garden problems on pests after we failed to promote a healthy ecosystem in which pests are kept under control by gardeners' friends, e.g. hover flies, lacewings, ladybirds, spiders, and various small birds. Blaming others for our problems while ignoring personal responsibility indicates emotional immaturity.

Although our survival depends on accurately identifying external threats, psychologically mature people also take responsibility for their own behaviour — they follow those three fingers pointing back at them. Such individuals recognize their ignorance (synonymous with evil) and try to learn from their mistakes. As gardeners know, if the garden's ecology is fundamentally unhealthy, pest eradication is no more than a temporary solution, whether the pests are expelled 1,030 times or 1,000,030 times.

Both the cause and solution to our problems are ultimately spiritual. Life-enhancing action will flow from increased spiritual awareness. An added advantage to Nature / God-conscious living is that it will likely attract the support of Nature / God-conscious ETs such as the Anunnaki and the Nordics. The Stress and Coping section focuses on the specifics of more enlightened action.

### 4. Stress and coping

## 4.1 A framework

The predominant model of stress and coping in psychology<sup>1,2</sup> acknowledges four categories:

1. **Stressors** — situations, problems.
2. **Coping** — thoughts and behaviour in response to stressors.
3. **Outcomes**, e.g. stress, stress-related symptoms, illness.
4. **Coping resources**, e.g. health; social support (including racial cohesiveness, and potentially the support of ETs); knowledge / skill; personality factors (e.g. intelligence, creativity, hardiness); spirituality; and material resources (including the natural environment).

Coping resources are also referred to as moderator variables (they moderate the relationship between stressors and outcomes), vulnerability factors or resilience factors.

Stress occurs when the demands of stressors tax or exceed coping resources. Effective coping reduces stress. For situations that are changeable, effective coping involves efforts to change the situation (problem-focused coping), e.g. financial stress can be reduced by leading a simpler lifestyle, work stress can be reduced by changing jobs, societal stress can be reduced by serving justice on the gangsters controlling our societal levers. For situations that are not changeable (e.g. permanent disability, loss of a loved one, terminal illness) effective coping involves efforts to reduce the severity of stress (emotion-focused coping), e.g. catharsis (releasing emotions through talk, crying, laughter, music, writing, art), spiritual activities (meditation, being in nature), social support (being with friends who understand, accept and love us). Concerning social support, even just one close confiding relationship can substantially improve coping during times of stress.

Naturally these four categories are interrelated, e.g. illness can be an outcome, stressor, and it can mean reduced coping resources. Same for the loss of a supportive interpersonal relationship and many other factors that can occur in several categories.

## 4.2 Effective coping

The first step in effective coping is accurate assessment of the situation and the extent to which it is changeable. Processes that are beyond human control include those of the solar system, the cycle of ages in Hindu cosmology (discussed in [this post](#)), glacial / inter-glacial periods, geological ages, and the spiritual principle of cause and effect (aka karma, Örlög, Wyrð, God's immune system) to which we are all subject.

For example, God is reacting to humans' destruction of His creations (the ecological catastrophe known as the [Holocene extinction](#)).

In contrast, among the many ways in which we can influence our future to some extent are our choice of religion (e.g. anti-life Abrahamic religion vs pro-life natural religion), lifestyle (e.g. destructive consumerism vs Nature/God-conscious living) and politics (e.g. submitting to our attackers vs removing them from power by means that include support for leaders who stand for truth, life, and justice).

Our dire societal situation is changeable. We have the necessary resources. We also have increasing psychological pain to trigger us into carrying out the solution before the end of this solar cycle peak.

## 5. The turning point

Anticipated or actual loss of valued resources (e.g. availability of food, buying power / standard of living, interpersonal relationships through death) is a more powerful motivator of behaviour-change than is the anticipated gain of valued resources. Usually people cannot be helped to change their negative behaviour to positive behaviour until their old ways have resulted in substantial personal suffering. The more our attackers maltreat us during their final days in power, the closer they get to triggering an age-ending reaction to their Talmudic evil.

### 5.1 When will the explosion occur?

As sure as day follows night, there will be an almighty explosion soon. This cannot be prevented. Attempts to suppress the reaction will inflame it. An astute comment on the critical point comes from a jew quoted by Nesta Webster in Chapter 8 of Germany and England (1938):<sup>3</sup>

- I am a jew in the marrow of my bones.
- The jews desire world domination — all my life I have heard them speak of it.
- I am afraid they will attain it. But that can be only for a moment.
- The nations of the world will not be able to bear so intolerable a tyranny.
- They will rise and there will be the greatest pogrom [an organized persecution or extermination of jews] the world has ever seen.

As Nesta Webster writes after this comment, "Those friends of the jews who encourage them in their thirst for power are thus their cruelest enemies."

It seems that the Talmudic aliens' best hope is to get the hell out of Dodge now — load

the stolen gold onto Grey alien mother ships and head for Zeta Reticuli.


## 6. Celebration of 'Z'

Eihwaz is a powerful rune of life, death, and defence. During summer Eihwaz is ruled by Odin. Eihwaz stands for the letter Z.<sup>4</sup>

As

As represents the mouth, the divine breath of all life and creation, and intellectual

activities. It is the 'god rune'. In the Hindu tradition, it is the Sanskrit primal sound which created the present universe.
